**AMENDMENT TWO****1. BACKGROUND AND PURPOSE.**

- 1.1 **Background.** Pima County ("County") and Loyola Associates *dba* Jose Gabriel Loyola ("Contractor"), entered into the above referenced contract to provide technical assistance for WIOA programs.
- 1.2 **Purpose.** County operates a workforce development program at ARIZONA@WORK (an American Job Center formerly the Pima County One Stop).
  - 1.2.1. Contractor has the expertise and proximity to Phoenix WIOA legislation.
  - 1.2.2. County wishes to continue WIOA technical assistance provided by Contractor for an additional year.

2. **TERMS AND EXTENSIONS, SECTION 1.0** is amended as follows:

2.1 **Paragraph 1.1** is amended to change the termination date:

FROM: December 31, 2019

TO: December 31, 2020

2.2 **Paragraph 1.2** is amended to acknowledge that there are no remaining Extension Options.

3. **COMPENSATION AND PAYMENT, SECTION 3.0** – is amended as follows:

3.1 **Paragraph 3.1** is amended to increase the “Maximum Allocated Amount”:

Pursuant to A.R.S. § 35-393.01, if Awardee engages in for-profit activity and has 10 or more employees, and if this Agreement has a value of \$100,000.00 or more, Awardee certifies it is not currently engaged in, and agrees for the duration of this Agreement to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.




