

AMENDMENT TO LEASE

- 1. **DEFINED TERMS**. For purposes of this Amendment, the following terms have the meanings set forth below:
 - 1.1. <u>Landlord</u>: Pima County, a political subdivision of the State of Arizona (hereinafter referred to as "Landlord")
 - 1.2. <u>Tenant</u>: Friends of Robles Ranch dba My Friends Closet, an Arizona non-profit corporation
 - 1.3. Premises: See Exhibit "A"
 - 1.4. <u>Lease</u>: The lease for the leased Premises naming Tenant as tenant, dated November 17, 2015
 - 1.5. Effective Date: January 1, 2020
- 2. **MODIFICATION OF LEASE**. Landlord and Tenant hereby agree to modify the terms of the Lease as follows:
 - 2.1. The Term of the lease is hereby extended to December 31, 2020
- 3. **REMAINING LEASE TERMS UNCHANGED**. Except as modified as provided in this Amendment, all of the terms and conditions of the Lease shall remain in full force and effect.
- 4. **EFFECTIVE DATE**. This Amendment shall be effective as of the Effective Date.
