Title: Canoa Ranch Road Speed Limit

Introduction/Background:

The Pima County Department of Transportation has determined the need to establish prima facie reasonable speed limits on Canoa Ranch Road between Interstate 19 and Camino Del Sol.

Discussion:

This segment of Canoa Ranch Road was constructed under a subdivision development permit in 2003. The design speed for Canoa Ranch Road was established as 35 mph. A roundabout is located on the east end of Canoa Ranch Road where it intersects the Interstate 19 frontage road within ADOT right of way. Existing speed limit signs are installed on this section of Canoa Ranch Road, however there is no associated ordinance.

Conclusion:

This ordinance will establish the speed limit on Canoa Ranch Road between Interstate 19 and Camino Del Sol.

Recommendation:

The Pima County Department of Transportation recommends that the speed limit on Canoa Ranch Road be establised as 35 mph from Camino Del Sol to 0.377 miles east of Camino Del Sol and as 25 mph from 0.377 miles east of Camino Del Sol to the Pima County right of way line.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; ESTABLISHING REASONABLE AND PRUDENT SPEED LIMITS FOR MOTOR VEHICLES ON CANOA RANCH ROAD IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627, 28-701 and 28-703 to fix reasonable and prudent speed limits on a through County highway.
- 2. The Board of Supervisors has determined a reasonable and prudent speed limit for motor vehicles on Canoa Ranch Road in Pima County.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA,

SECTION 1. The following speed limit is established as reasonable and prudent speed limit for Canoa Ranch Road in Pima County:

b)	25 mph	0.377 miles east of Camino Del Sol	0.538 miles east of

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This Ordinance takes effect when and to the extent that signs are posted on the highway listed in Section 1 of this Ordinance, giving notice of the new speed limit, but in no event earlier than 30 days from the date of adoption of this Ordinance.

SECTION 4. The various County officers and employees are authorized and directed to Speed Limit – Canoa Ranch Road
