CONTRACT AMENDMENT - Board of Supervisors

The parties agree to amend the above-referenced contract as follows:

- Background and Purpose. On February 4, 2018 the Board of Supervisor approved the 1. original two year agreement with Racy Associates, Inc. for federal lobbying services. The agreement can be extended for up to 4 additional 1-year periods. County requires additional continued representation of lobbyist services related to federal legislation.
- 2. **Term.** The Term of the Contract is hereby extended to February 3, 2022.
- 3. Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in Section 5, is increased by \$300,000.00 (\$150,000.00/ per year). County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$600,000.00.

The effective date of this Amendment is February 3, 2020.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
