Requested Board Meeting Date: January 21, 2020

**Title:** Limberlost Road No Stopping, Standing or Parking

### **Introduction/Background:**

The Pima County Department of Transportation received a request from the Tanque Verde High School to prohibit parking during school hours on the north side of Limberlost Road, south of the Tanque Verde High School sports fields due to safety concerns. Limberlost Road is a local roadway with a 25 mph speed limit.

### **Discussion:**

Tanque Verde High School staff is concerned with the safety of students that are parking on the north side of Limberlost Road, instead of in the school parking lot adjacent to the high school.

### **Conclusion:**

Pima County Department of Transportation staff observed vehicles parked on the north side of Limberlost Road during school hours.

### **Recommendation:**

The Pima County Department of Transportation recommends a No Stopping, Standing or Parking ordinance be approved for the northside of Limberlost Road from Melpomene Way to 680 feet west of Melpomene Way 7:30 am to 3:30 pm School Days Only. The ordinance comes in to effect when and to the extent that signs are posted on the roadway.

ORDINANCE 2020 - \_\_\_\_\_

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING PARKING ON LIMBERLOST ROAD IN PIMA COUNTY, ARIZONA**

**THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:**

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-873 as amended, to regulate the stopping, standing or parking of vehicles.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish that vehicles should not stop, stand or park on portions of Limberlost Road.

**BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:**

SECTION 1. Parking on Limberlost Road shall be regulated as No Stopping, Standing or Parking as follows:

- a) Parking on the south side of Limberlost Road from Melpomene Way to 1300 feet west of Melpomene Way be regulated as No Parking Anytime;
- b) Parking on the north side of Limberlost Road from 620 feet west of Melpomene Way to 1300 feet west of Melpomene Way be regulated as No Parking Anytime;
- c) Parking on the north side of Limberlost Road from Melpomene Way to 680 feet west of Melpomene Way be regulated as No Stopping, Standing, or Parking between 7:30 am and 3:30 pm School Days Only.

SECTION 2. Ordinance 2010-49 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
