



I, Reverend Robert Rankin, Pastor of Saint Melany Byzantine Catholic Church, Tucson, of the Holy Protection of Mary Byzantine Catholic Eparchy of Phoenix, acting as incorporator of a corporation sole pursuant to Arizona Revised Statutes ("ARS") sections 10-11901 through 10-11908, do hereby certify, state and subscribe as follows:

ARTICLE I. Name. Pursuant to ARS section 10-11903(A)(1), the name of the corporation sole is PASTOR OF SAINT MELANY BYZANTINE CATHOLIC CHURCH, TUCSON.

ARTICLE II. Purpose and Character of Affairs.

Section 1. Pursuant to ARS section 10-11903(A)(2), this corporation sole is organized and shall be operated exclusively for religious purposes within the meaning of Internal Revenue Code ("IRC") section 501(c)(3). These purposes shall include, without limitation, operating as a parish of the canonical juridic person known as the Holy Protection of Mary Byzantine Catholic Eparchy of Phoenix (the "Eparchy") subject to the ecclesiastical authority of the bishop holding the ecclesiastical office of Bishop of the Eparchy in ecclesial communion with the Roman Pontiff (the "Eparchial Bishop"), managing the temporal affairs of the parish, and providing for the spiritual and temporal needs of people in strict conformity with the disciplines, doctrines, and teachings of the Catholic Church as interpreted by the Roman Pontiff (i.e., the Pope) and promulgated by the Holy See, including the Codex canonum ecclesiarum orientalium promulgated by the Roman Pontiff, His Holiness, Pope John Paul II on October 18, 1990 by the Apostolic Constitution Sacri canones, as amended from time to time, or corresponding future code of canon law that may be promulgated by a successor Roman Pontiff (the "Eastern Code of Canon Law"), such other applicable canon law as may be

promulgated by the Pope, and any particular law promulgated by the Eparchial Bishop (collectively, "Eastern Canon Law"). In all such matters, this corporation sole shall rely upon and defer to the ecclesiastical authority proper to the Eparchial Bishop. Except as otherwise provided in these Articles and subject to the requirements of Eastern Canon Law, this corporation sole also may transact any and all lawful business for which corporations sole may be organized under the laws of Arizona, as amended from time to time.

Section 2. The Eparchy is a portion of the people of God entrusted to the Eparchial Bishop to shepherd, with the cooperation of the presbyterate of the Eparchy, in such a way that, spiritually adhering to the Eparchial Bishop and gathered by him through the Gospel of Jesus Christ and the Most Holy Eucharist in the Holy Spirit, the Eparchy constitutes a "particular church" in which the one, holy, catholic, and apostolic Church of Christ truly exists and is operative (cf. Canon 177 of the Eastern Code of Canon Law). Saint Melany Byzantine Catholic Church is a definite community of the Christian faithful established on a stable basis within the Eparchy (though existing separately from the Eparchy, both canonically and civilly), whose pastoral care is committed to the priest holding the ecclesiastical office of pastor (parachus under the Eastern Code of Canon Law) or. in the event of a vacancy in such office and only for the period of vacancy in such office, the individual duly-appointed by the Eparchial Bishop as parochial administrator of Saint Melany Byzantine Catholic Church (the "Pastor") in accordance with the disciplines, doctrines, and teachings of the Catholic Church as interpreted by the Roman Pontiff and promulgated by the Holy See, including Eastern Canon Law. By virtue of his inherent ecclesiastical authority as set forth in the disciplines, doctrines, and teachings of the Catholic Church, the Bishop of the Eparchy enjoys the following privileges vis-à-vis this corporation sole: (i) to remove or reassign, with or without cause, the incumbent Pastor of Saint Melany Byzantine Catholic Parish in accordance with Eastern Canon Law; (ii) to fill any vacancy occurring in the office of Pastor of Saint Melany Byzantine Catholic Parish, Tucson, regardless of the cause for such vacancy, in accordance with Eastern Canon Law; and (iii) to inspect the books and records of this corporation sole at any time. In the event of a vacancy in the office of Eparchial Bishop, the above privileges shall be enjoyed by the canonical administrator of the Eparchy in accordance with Eastern Canon Law ("Canonical Administrator"), but only for as long as such office of Eparchial Bishop is vacant.

Section 3. The territory comprising Saint Melany Byzantine Catholic Church, Tucson, in which the canonical jurisdiction of this corporation sole shall be exercised and to which it shall extend, consists of the boundaries of Saint Melany Byzantine Catholic Church, Tucson, as such boundaries may be decreed and/or established from time to time by the decree of the Eparchial Bishop.

ARTICLE III. Activities and Restrictions.

Section 1. No part of the net earnings of this corporation sole shall inure to the benefit of, or be distributable to any members, directors, officers, or other private persons, except that this corporation sole shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II. No substantial part of the activities of this corporation sole shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation sole shall not participate in, or intervene in (including through the publishing or distribution of statements) any political campaign on behalf of any candidate for Notwithstanding any other provisions of these Articles, this corporation sole shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation sole, and this corporation sole shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income taxation under IRC section 501(c)(3), or (ii) by a corporation, contributions to which are deductible under IRC section 170(c)(2).

Section 2. These Articles of Incorporation may not be amended, in whole or in part, without the express prior written consent of the incumbent Eparchial Bishop. Any purported amendment to these Articles without the express prior written consent of the incumbent Eparchial Bishop shall be void *ab initio*. In the event of, and only for as long as, a vacancy in the office of Eparchial Bishop, these Articles may not be amended, in whole or in part, without the express prior written consent of the Canonical Administrator.

Section 3. This corporation sole may not, and shall not, merge or dissolve, or sell, lease, convey, exchange, transfer, or otherwise dispose of any of its real property and/or all or substantially all of its other assets without the express prior written consent of the incumbent Eparchial Bishop in addition to any other approvals required by civil law or under Eastern Canon Law. Any purported action described in the preceding sentence taken without the express prior written consent of the incumbent Eparchial Bishop shall be void *ab initio*. In the event of, and only for as long as, a vacancy in the office of Eparchial Bishop, the above actions shall require the express prior written consent of the Canonical Administrator.

ARTICLE IV. <u>Canonical Authority</u>. Pursuant to ARS section 10-11903(A)(4), I, Reverend Robert Rankin, am a duly-ordained priest of the Byzantine Catholic Church in good standing, and currently serve as, and my title currently is, the Pastor of Saint Melany Byzantine Catholic Church, pursuant to the appointment of the Eparchial Bishop. I am authorized by the Eparchial Bishop, Eastern Canon Law, and other applicable statutes, decrees, policies, guidelines, directives, and orders of the Eparchial Bishop and/or the Roman Pontiff to organize this corporation sole.

ARTICLE V. <u>Dissolution</u>. In the event of the dissolution of this corporation sole, this corporation sole shall, after paying or making provision for the payment of all the lawful debts and liabilities of this corporation sole, distribute all of the assets of this corporation sole to a Byzantine Catholic organization as determined by the incumbent Eparchial Bishop; provided that (i) such organization, at the time of this corporation sole's dissolution, is operated for religious purposes consistent with one or more purposes set forth in Article II hereof and is described in IRC sections 501(c)(3) and 509(a)(1) or 509(a)(2); and (ii) the distribution to such organization conforms with the disciplines, doctrines, and teachings of the Catholic Church, including Canon 930 of the Eastern Code of Canon Law and other relevant provisions of Eastern Canon Law.

ARTICLE VI. Estimated Value of Property at Incorporation. Pursuant to ARS section 10-11903(A)(3), this corporation sole holds property with an estimated value equal to approximately \$53,000 at the time of drawing up these Articles. All real property owned by this corporation sole at the time of the filing of these Articles of Incorporation is located within Maricopa County, Arizona.

ARTICLE VII, Indemnification. To the fullest extent permitted by applicable law, this corporation sole shall indemnify and advance expenses to any person who incurs expenses or liabilities by reason of the fact that he or she is or was an officer, director, employee, or agent of this corporation sole or is or was serving at the request of this corporation sole as an officer, director, employee, or agent of another foreign or domestic corporation, partnership, joint venture, trust, employee benefit plan, or other entity. The foregoing indemnification and advancement of expenses shall be mandatory in all circumstances in which the same are permitted by applicable civil law and shall include the indemnitee's spouse if such spouse incurs expenses or liabilities by reason of the fact that he or she is or was married to an officer, employee, or agent of this corporation sole or to someone who is or was serving at the request of this corporation sole as a director, trustee, officer, employee, or agent of another foreign or domestic corporation, partnership, joint venture, trust, employee benefit plan, or other entity. No repeal, amendment, or modification of this Article VII, whether direct or indirect, shall eliminate or reduce its effect as to any matter giving rise to indemnification and advancement of expenses occurring before such repeal, amendment, or modification.

ARTICLE VIII. <u>Director Liability</u>. To the fullest extent permitted by applicable law, no director of this corporation shall be liable to this corporation sole for monetary damages for any action taken or any failure to take any actions as director. Process for Establishing NEW Corporate Parish Bank/Saving Accounts

- <u>Premise:</u> Since all parishes have been established as separate and individual corporate entities with the recent new restructuring, we are ready to open new parish bank checking and saving accounts.
- All current bank accounts, as well as investment accounts, were opened under the Eparchy of Van Nuys federal employer identification number (EIN). Since each new parish corporation now has its own new separate EIN, all accounts, bank and investment, with the Eparchy of Van Nuys EIN *must be closed* and new bank/saving accounts, as well as investment accounts, must be opened under the new corporate name with its proper EIN.
- New bank accounts must be opened by November 30, 2015 and be ready to begin operation on January 1, 2016 implementing the new chart of accounts. Until that time, the current bank/saving accounts will continue operating until December 31, 2015 so that we can complete this calendar year with the present accounts and current chart of accounts.

Please note that you must use either the official corporate name or the state-filed fictitious or DBA (Doing Business As) name for all accounts and for all checks. NO DEVIATIONS from this are acceptable! It is better to ask before use than to have to close newly opened accounts or to purchase new checks.

To help you undertake this transition to close and open new accounts, please use the following process:

- Determine the number of accounts you will be opening. The Eparchial Finance Office (EFO) recommends
 opening one operational account and one or two savings/money market accounts for the time being.
- 2. Choose the banking institution where you want your new accounts to be opened. You may remain at your current bank.
- 3. Make an appointment to open your new accounts at your bank. This appointment can be time consuming.
- 4. You will need to bring with you the following documentation: Parish Articles of Incorporation, parish new EIN, Official Catholic Directory section for our Eparchy, and Corporate Resolution or Actions of the Corporate Sole.
- 5. Be prepared to transfer a minimum amount of money to activate the new accounts.
- 6. The signers on all the accounts **must include the pastor and the Bishop**, along with one or two trustworthy parishioners. (Trust criterion: I would have them as signers on my personal bank accounts!) All new signers should need a credit check from the banking institution.
- 7. Once the accounts are open and you have all the account information, order checks either through the bank or some checking service such as Intuit (QuickBooks), Deluxe Checking, Costco, etc. Remember that your checks must be 2-stub voucher checks that must be printed using QuickBooks on the computer. Additionally, you can order endorsement stamps from the same company or from the bank. Checks cannot be ordered until the new bank accounts are opened and the account and routing numbers are assigned by the bank.
- 8. Deacon Michael or Father Wes will come to the parish and install the new chart of accounts it is basically the same with some tweaks and open your new accounts on QuickBooks Pro 2014, or the Apple computer equivalent. (Remember, you were asked to purchase that edition.)
- 9. On January 1, 2016, begin using the new parish accounts.
- 10. At the beginning of February, when reconciling the old bank account statement in QuickBooks, be sure that ALL outstanding checks have cleared. When all of the outstanding checks are cleared, you can close the old checking account and transfer the balance to the new checking account.
- 11. When the old December, 2015 savings accounts have been reconciled, go to the bank and close those accounts and transfer any money to the new savings account. If you should have a CD that has not completed its cycle for maturity, wait until the maturity date and then close the CD, transferring the money to the new savings.

You have further represented that none of your subordinate organizations is a private foundation under section 509(a), although all subordinates do not all share the same sub-classification under section 509(a). Based on your representations, the subordinate organizations in the Official Catholic Directory for 2016 are recognized as exempt under section 501(c)(3) of the Code under GEN 0928.

Donors may deduct contributions to you and your subordinate organizations as provided in section 170 of the Code. 
