Amendment of Award: Master Agreement No. MA-PO-19-230, Amendment No. 03. This Amendment increases the annual award amount by \$180,000.00 from \$250,000.00 to \$430,000.00 for a cumulative not-to-exceed contract amount of \$430,000.00.

Administering Department: Transportation.

*Procurement Method:

Pursuant to Pima County Procurement Code 11.24.010, Cooperative procurement authorized, on July 15, 2019, the Procurement Director approved an award of contract for an initial term from August 1, 2019 to October 26, 2021 and an annual award amount of \$130,000.00.

Effective August 1, 2019, the Procurement Officer processed Amendment No. 01 which increased the price for commodity lines 1 and 2 in accordance with the State of Arizona contract no. ADSPO17-152519.

On 10/30/2019, the Procurement Director approved Amendment No. 02 which increased the annual award by \$120,000.00 from \$130,000.00 to \$250,000.00 for a cumulative not-to-exceed contract amount of \$250,000.00.

This increase is needed due to efficiencies with product, equipment, and staffing, which led to requiring more product than expected.
