Andrew Flagg, Chief Civil Deputy County Attorney, stated that the County Attorney's Office sought direction on whether to proceed with defending against the lawsuits as discussed in Executive Session.

It was moved by Supervisor Bronson, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to proceed as discussed in Executive Session.

10. CALL TO THE PUBLIC

Geri Ottoboni addressed the Board regarding local media and opposition to the Board's appointment for Constable, Justice Precinct 9.

Dylan Smith spoke regarding government transparency and updating the County's public records policy.

The following speakers addressed the Board in opposition of the Stonegarden Grant:

- Steve Diamond

They offered the following comments:

- The amount of money spent by the County in relation to the Stonegarden Grant was greater than the funds provided by the grant.
- Stonegarden funding should be rejected for ethical, financial and operational reasons.
- Operation Stonegarden was immoral, unjust, inequitable and fundamentally at odds with the values of the community.

Raquel Baranow addressed the Board regarding the abandonment of her property.

FINANCE AND RISK MANAGEMENT

Supervisor Miller indicated that this contract was continued because the Board had questioned using an outside contractor versus utilizing County staff. She stated that the question was not sufficiently answered.

A substitute motion was made by Supervisor Valadez to continue the item to the Board of Supervisors' Meeting of February 4, 2020, to allow staff to answer the previous question, as well as provide an explanation for which County department was responsible for oversight of this contract. Chairman Elías seconded the motion. No vote was taken at this time.

Chuck Huckelberry, County Administrator, indicated that a memorandum was provided to the Board on January 9, 2020. He stated that the memorandum detailed the scope of the contract and the rationale for extending the contract. He added that staff would provide the additional information requested.

Supervisor Miller commented that the expertise should be developed in-house in order to eliminate the expenditure.

Upon the vote, the substitute motion unanimously carried 5-0.

Discussion/Action/Direction regarding the Sheriff's Operation Stonegarden Grant (OPSG) proposal of December 17, 2019, transmitted to the Board of Supervisors on January 2, 2020, including but not limited to the acceptance of Federal Fiscal Year 2018 OPSG Overtime and Mileage Grant, the OPSG Equipment Grant, and the Rural Law Enforcement Unit. (District 4)

Without objection, the item was continued to the Board of Supervisors' Meeting of February 4, 2020.

COUNTY ADMINISTRATOR

21. Authorization to Loan \$1,800,000.00 to the Catalina Foothills Unified School District No. 16

Staff recommends the Board of Supervisors authorize the Finance and Risk Management Director to enter into a short-term, interest free loan document with a one year payback with the Catalina Foothills Unified School District No. 16 to temporarily cover the levy shortfall of \$1.8 million.

It was moved by Supervisor Miller and seconded by Supervisor Christy to approve the item. No vote was taken at this time.

Chairman Elías asked that the County Administrator brief the Board on this item.

Chuck Huckelberry, County Administrator, explained that for Fiscal Year 2019/20, during the progression of the tax levy submissions from Catalina Foothills Unified School District the override component of the levy was overlooked. He noted that the County had sufficient funds to loan the Catalina Foothills Unified School District the \$1.8 million shortfall until it could be levied the following year.

Upon the vote, the motion unanimously carried 5-0.

It was moved by Supervisor Bronson and seconded by Supervisor Valadez to approve the item. No vote was taken at this time.

Supervisor Miller inquired why a separate non-profit entity was created when its objectives and activities were the jurisdiction and responsibility of Visit Tucson.

Chuck Huckelberry, County Administrator, explained that the scope of Tucson City of Gastronomy was more specific and focused. He noted that Visit Tucson also contributed to the organization.

Supervisor Miller expressed concern over County funding being utilized by the organization to fund employee salaries instead of providing support for activities. She inquired whether this would be an annual expenditure.

Mr. Huckelberry responded that Tucson was designated a United Nations Education Scientific and Cultural Organization City of Gastronomy, and contributions were expected to continue.

Supervisor Christy asked whether the project was related to the Best 23 Miles of Mexican Food venture.

Mr. Huckelberry stated that the Best 23 Miles of Mexican Food would qualify as a component, but did not represent the entirety of the objective.

Upon the vote, the motion carried 4-1, Supervisor Miller voted "Nay."
