**AMENDMENT THREE****1. BACKGROUND AND PURPOSE.****1.1 Background.**

- 1.1.1. On April 4, 2017, Pima County ("County") and The Center for Life Skills Development, L.L.C. ("Awardee"), entered into the above-referenced contract to provide behavioral health counseling services for adults, dislocated workers, and youth.
- 1.1.2. County, as Grantee, receives Workforce Innovation and Opportunity Act ("WIOA") grant funds from the U.S. Department of Labor and provides them to subrecipients, including Awardee, to provide eligible services. The WIOA grant ends June 30, 2021.
- 1.1.3. The Board of Supervisors accepted additional WIOA funds on October 15, 2019 (GTAM-CS-20-007).

- 1.2 **Purpose.** County operates a workforce development program at Pima County ARIZONA@WORK (an American Job Center, formerly the Pima County One Stop).
- 1.2.1. Awardee has the expertise to provide behavioral health counseling.
- 1.2.2. County wishes to continue behavioral health counseling services provided by Awardee for an additional year.
- 1.2.3. County has reviewed Awardee's performance of the services and finds it satisfactory.

**2. TERMS AND EXTENSIONS, SECTION 1.0, paragraph 1.1 is amended as follows:**

- 2.1 The termination date is changed:  
 FROM: March 31, 2020  
 TO: March 31, 2021
- 2.2 The number of available renewals is changed:  
 FROM: two (2) additional years or any portion thereof  
 TO: one (1) additional year or any portion thereof

**3. COMPENSATION AND PAYMENT, SECTION 3.0 is amended as follows:**

- 3.1 **Paragraph 3.1** is amended to increase "the Maximum Allocated Amount":  
 FROM: \$15,000.00  
 TO: \$20,000.00
- 3.2 **Paragraph 3.2**, the table is deleted in its entirety and replaced with the following:

This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.
