WHEREAS, Supervisor Elías served as Chairman of the Pima County Board of Supervisors at the time of his untimely passing on March 28, 2020, a leadership position he was appointed to by his colleagues in 2018, he also proudly served as Chairman from 2006 through 2010; and

WHEREAS, Chairman Elías was also known for his sense of style, whether it was his preference of an open collar or the use of a bolo tie. His time-honored mantra of "Resist and Much Love" truly reflected his passion as a music aficionado and fervent fan of the Grateful Dead, Los Lobos, The Clash, and Bob Marley; and

WHEREAS, Chairman Elías represented his District with distinction and is known as being a people's champion for many social justice causes, including advocating for working families, marginalized communities and rank-and-file employees. He was committed to issues relating to neighborhood reinvestment, affordable housing, the Sonoran Desert Conservation Plan, quality health care, and employment and training, which reflected his desire of making Pima County a much better place to live, work and play.

NOW, THEREFORE, BE IT RESOLVED that a very grateful Pima County and his colleagues on the Board of Supervisors do hereby convey our most heartfelt condolences to his wife, Emily, his daughter Luz, his brother Albert (Sarah), his sister Ana, his nieces and nephews Elena, Adriana, Matt and Ben, as well as his entire family on this very deep and personal loss.
