AMENDMENT TO LEASE

- **DEFINED TERMS**. For purposes of this Amendment, the following terms have the 1. meanings set forth below:
- Landlord: Pima County, a political subdivision of the State of Arizona (hereinafter referred to as "Landlord")
- Tenant: Arizona Board of Regents, a body corporate on behalf of the University of Arizona Cooperative Extension
- Leased Property: See Attached Exhibit "A" and Leased Premises see Attached 1.3. Exhibit "B".
- Lease: The lease for the Leased Premises naming Tenant as tenant, dated July 1, 1.4. 2017.

- 1.5. Effective Date: July 1, 2020.
- 2. **MODIFICATION OF LEASE**. Landlord and Tenant hereby agree to modify the terms of the Lease as follows:
- 2.1. Rent: The rent for the property shall be \$125.00 per month, with an annual increase of \$25.00.
 - 2.2. Term: The term of the Agreement is hereby extended to an additional 5 year term.
- 2.3. <u>Premises:</u> The Premises will include additional property See Exhibit "B-1" and Tenant agrees that no structures are to be installed.


