CONTRACT AMENDMENT #1

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

- 1.1 <u>Background</u>. On June 5, 2019, County and Contractor entered into the above referenced agreement to provide representation of Pima County, Brian Hill, and Mark Napier in *Holguin v. Pima County et al.*, Pima County Superior Court case no. C20192192.
- 1.2 <u>Purpose</u>. The County requires a year extension on the Contract so that services will continue to be available.
- 2. Term. The term of the Contract is hereby extended to June 4, 2021.

3. Add the following as paragraph 28:

Israel Boycott Certification. Pursuant to A.R.S. § 35-393.01, if Contractor engages in forprofit activity and has 10 or more employees, and if this Contract has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Contract to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

The effective date of this Amendment is June 4, 2020.
