Title: Additional Emergency Voting Locations for the 2020 General Election

Introduction/Background:

Per A.R.S. 16-411(B)(5), authority is conferred on the Board of Supervisors to establish Emergency Voting locations for each election. At the Board Meeting on April 21, 2020 a number of sties were approved as emergency voting locations and it was suggested that several additional locations be added. The Recorder has been able to add three additional sites, per the request of the Board of Supervisors.

Discussion:

The Recorder proposes adding locations at the Wheeler Taft Library, the Mission Road Library and the TOKA Community Building in Sells to the list of locations already approved. A complete list is attached as Exhibit A, which includes these additional locations.

**A RESOLUTION OF PIMA COUNTY AUTHORIZING ADDITIONAL EMERGENCY VOTING
LOCATIONS FOR THE 2020 GENERAL ELECTION**

WHEREAS, the right to vote is a fundamental right of the citizens of this County as well as the nation, and

WHEREAS, it is in the best interests of Pima County to ensure citizens are still able to vote when extraordinary circumstances for the citizen arise, and

WHEREAS, the Recorder's Office will operate early voting locations throughout Pima County where voters can also drop off their ballot by mail ballots, and

WHEREAS, pursuant to A.R.S. § 16-411(B)(5) the Legislature has given the authority to the Board of Supervisors to authorize the County Recorder to operate emergency voting locations as designated by the Board, and

WHEREAS, the Board of Supervisors has previously approved several Emergency Voting locations for the 2020 General Election and desired that additional locations be named,

NOW THEREFORE BE IT RESOLVED, emergency voting will be available on Saturday, October 30, 2020 from 9:00 am to 3:00 pm and Monday, November 2, 2020 from the hours of 8:00 a.m. to 5:00 p.m. at the following additional locations:

1. Wheeler Taft Library located at 7800 N. Schisler Dr., Tucson;
2. Mission Road Library located at 3770 S. Mission Rd., Tucson;
3. TOKA Community Building located in Sells.
