This is a revenue agreement awarded to the county to administer energy program funding to eligible low-income clients for utility repair/replacement, utility deposits/bill assistance, mortgage/rental assistance and other emergency needs for Trico customers. This amendment adds TRICO Emergency Assistance funds of \$140,960.00

*Program Goals/Predicted Outcomes:

Trico funding to support Trico customers who reside in Pima County. Due to COVID-19, Community Services is experiencing an increased demand in services due to job loss, school closures and health and safety concerns. Services includes but is not limited to the following: utility assistance, rent assistance, eviction prevention, mortgage assistance, medical and food expenses. These critical services ensure low-income Pima County residents remain or become self-sufficient.

*Public Benefit:

The program will provide emergency assistance funds to eligible Pima County residents. The assistance will result in prevention of homelessness, continuation or restoration of utility services and/or maintain or replace utility-related apparatus to ensure the safety and health of Pima County residents experience hardships and/or crisis.

Independent Contractor Agreement

Contract No. 07012019-20

The Independent Contract Agreement dated July 1, 2019, between Arizona Community Action Association (dba Wildfire) and <u>Pima County</u>, on behalf of the <u>Pima County</u> - <u>Community</u> <u>Action Agency</u> (hereinafter "Contractor") to conduct application intake and eligibility determination for utility bill assistance and deposits is hereby amended as follows:
