**Title:** Cold Snap Place No Parking

### Introduction/Background:

The Pima County Department of Transportation received a request from the Fire Marshal of the Corona de Tucson Fire Department to restrict parking within the turnaround areas located on the east and west ends of Cold Snap Place in accordance with Chapter 5, Section 503.4 of the Arizona State Fire Code.

### Discussion:

Transportation staff conducted a field review of the area. Boats and recreational vehicles were observed parking within the turnaround areas on both the east and west ends of Cold Snap Place.

### Conclusion:

Based on the request from the Corona de Tucson Fire Department, it is recommended that parking be restricted within the turnaround areas on both the east and west ends of Cold Snap Place.

### Recommendation:

The Pima County Department of Transportation recommends that parking be restricted within the turnaround areas on Cold Snap Place from 270 feet east of Darlene Place to 330 feet east of Darlene Place and 260 feet west of Darlene Place to 380 feet west of Darlene Place.

ORDINANCE 2020 - \_\_\_\_\_

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING PARKING ON COLD SNAP PLACE IN PIMA COUNTY, ARIZONA**

**THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:**

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-873 as amended, to regulate the stopping, standing or parking of vehicles.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish that vehicles should not park within the turnaround areas located on the east and west ends of Cold Snap Place.

**BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:**

SECTION 1. Parking on both sides of Cold Snap Place be regulated as no parking for the following segment:

<u>FROM</u>	<u>TO</u>
260 feet west of Darlene Place	380 feet west of Darlene Place
270 feet east of Darlene Place	330 feet east of Darlene Place

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
