PROFESSIONAL SERVICE CONTRACT - AMENDMENT TWO

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.


1.1. <u>Background</u>. On <u>June 29, 2018, Pima</u> County ("County") and Nybakken Group L.L.C. ("Contractor") entered into the above referenced agreement for the provision of services to determine exceptional service needs of students at Pima Vocational High School ("PVHS") and provide teacher support and training.

1.2. <u>Purpose</u>. PVHS requires continued provision of Contractor's services during the 2020-2021 school year.

- Term. Pursuant to paragraph 2.2, County exercises the second of four (4) extension options. The Contract will terminate on June 30, 2021
- Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in Section 5, is increased by \$30,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$90,000.00.
- Scope of Services. This amendment has no revisions to the Scope of Services.
- 5. Israel Boycott Certification. Pursuant to A.R.S. § 35-393.01, if Contractor engages in forprofit activity and has 10 or more employees, and if this Contract has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Contract to not engage in, a boycott of goods or services from Israel.
