Funds will be used to purchase furniture, implement 21st century technologies, and provide culturally relevant college and career exploration and other learning in a peer mentor format at the 101Space.

**\*Program Goals/Predicted Outcomes:**

The goal of this project is to expand upon Pima County Public Library's learning lab for young adults. The "101" is the place for young adults wishing to take advantage of innovative learning opportunities that will open up a world of possibilities.

**\*Public Benefit:**

Community members will benefit by gaining access to cost prohibitive 21st century technologies and participating in real-world projects and activities that will lead to future employment.

**\*Metrics Available to Measure Performance:**

PCPL uses Project Outcome which offers simple survey evaluation instruments and an easy-to-use process. Library staff administer pre- and post-surveys for the relevant program and report results in an online survey portal. The Valencia Library Teen Advisory Board will conduct monthly focus groups to gain anecdotal evidence of how the space is perceived, providing a measure of success that will help to establish best practices for future programming. Additionally, comment boards will be placed within the space to encourage feedback from youth who balk at public interaction, offering an anonymous format for communication.

- e) the requirements of any other nondiscrimination statute(s) which may apply.

### **2. Debarment and Suspension**

The applicant shall comply with 2 C.F.R. part 3185 and 2 C.F.R. part 180, as applicable. The authorized representative, on behalf of the applicant, certifies to the best of his or her knowledge and belief that neither the applicant nor any of its principals:
