CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

1.1. <u>Background</u>. On July 1, 2017, County and Contractor entered into the above referenced agreement to provide property loss protection to the Sheriff's Auxiliary Volunteers of Green Valley District Area, Inc. vehicles.

- 1.2. <u>Purpose</u>. County to extend contract for one year.
- **2. Term.** The Contract terminates on June 30, 2021.
- 3. Maximum Revenue Amount. The maximum amount the County will receive under this Contract, as set forth in Section 7, is estimated to increase by \$3,500.00 from \$14,991.00. The new estimated revenue amount will be \$18,491.00.

The effective date of this Amendment is July 1, 2020.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
