State Gang Task Force Detention Liaison Officer (DLO) Units

#### \*Purpose:

Assign two detention officers to the DPS Gang and Immigration intelligence Team Enforcement Mission. Indirect costs are not allowed; see section IX Fees. Grant provides 75% funding for two detention officers. The purpose of this agreement is to enhance law enforcement services concerning gangs and criminal activities through the cooperative efforts of the parties. This action will accept additional funding and continue grant agreement through 6/30/2021.

#### \*Procurement Method:

This IGA is a non-Procurement contract and not subject to Procurement rules.

#### \*Program Goals/Predicted Outcomes:

Collect intelligence and report criminal street gangs, prison gangs, security threat groups, human smuggling, illegal immigration and other criminal activities. Incorportate the information collected during such routine duties to complement law enforcement activities outside the facilities. The DLO activities and information collected and documented serves to inform agencies statewide and assists in solving criminal cases.
