Title: Sergio Baeza - Tax Sale (TS-0039)

Introduction/Background:

Resolution for sale of land, conveyed to State by Treasurer's Deed, to Sergio Baeza.

Discussion:

On October 19, 1967, tax parcel 118-22-1700 (the "Property") was conveyed by Treasurer's Deed to the State of Arizona. The Property consists of approximately 7,743 sq. ft. of vacant land located at 414 W. 27th Street. The sale of the property is pursuant to ARS 42-18303, to the high bidder, Sergio Baeza.

Conclusion:

The County Treasurer's office will receive revenue for the property that has been conveyed to the State of Arizona for delinquent taxes. The Property has been off the tax roll since 1967 and will be restored to the roll.

Recommendation:

It is recommended that the Board of Supervisors approve the Resolution authorizing the sale of the property to Sergio Baeza, a married man.

Fiscal Impact:

The sum of \$35,000.00, which includes an administrative fee of \$1,000.00, will be received for the Property that has been conveyed to the State for delinquent taxes.

The Chairman and Clerk of the Board shall execute and acknowledge a deed for the parcel to the said bidder, and after the sum of \$35,000.00 has been paid to the Pima County Treasurer pursuant to A.R.S. §42-18303; said deed shall be recorded; and

That the Pima County Treasurer is hereby directed to strike from the tax rolls all outstanding taxes now due and owing on the subject property.
