# \*Project Title/Description:

Workforce Assistance for the Homeless. The contract and amendments can be found in OnBase by searching Contracts CR-20\*425 (formerly CS-16\*358) in Doc ID\_AMS.

# \*Purpose:

This amendment allows SER, a subrecipient, to continue providing critical workforce activities to homeless youth, veterans, families and individuals as part of the Sullivan Jackson Employment Center (SJEC) program.

SER will continue to provide an outreach function to individuals and families living in washes, cars and other sites by responding to contacts under County Homeless Protocol. As part of the outreach, basic assessment is conducted and a search for Permanent Housing is made. Contractor also provides emergency shelter/motel vouchers for families to maintain family unity and at-risk youth for the purpose of safety.

SER will continue to provide case management and support services to participants engaged in SJEC's program. Support services are in addition to those normally available through Community Services system such as bicycles and household goods for families and individuals moving into Rapid Rehousing. Rapid Rehousing is considered by U.S. Department of Housing & Urban Development to be Permanent Housing that maintains a "Transition-in-Place" approach to housing people experiencing homelessness.

SER will continue to provide intense, structured employability skills workshops.

This amendment will provide additional funding for the period July 1, 2020 to June 30, 2021.

#### \*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.020, Competitive sealed proposals, RFP No. RFP-CSET-WFS-2016-06 was conducted with delegated authority.

# \*Program Goals/Predicted Outcomes:

SER will ensure that 80% of homeless participants who enter SJEC enroll in employability skills workshops and 50% will find employment and earn at least \$12.00 per hour.

#### \*Public Benefit:

This program supports Pima County's economic development by helping to develop a trained and productive labor force that meets employers' needs.

#### \*Metrics Available to Measure Performance:

SER will report monthly numbers of participants who completed the program and average wage of placement.

#### \*Retroactive:

Yes. Due to finalizing the amendment and delays in getting signatures. The negative impact of not approving this amendment is homeless youth, veterans, families and individuals would not receive workforce assistance for an additional year.

# **AMENDMENT SEVEN (7)**

# 1. BACKGROUND AND PURPOSE.

#### 1.1 Background.

- 1.1.1. On June 21, 2016, Pima County ("County") approved the above-referenced contract with SER-Jobs for Progress of Southern Arizona, Inc. ("Awardee"), to provide workforce development services for the homeless.
- 1.1.2. Funds have been awarded to County from DOL, HUD, City of Tucson ECHO Program, PCLRRP, and SSBG grants for services in FY2020-2021.
- 1.2 County Organization. Effective July 1, 2020:
  - 1.2.1. Pima County Community Services, Employment and Training Department and Pima County Community Development and Neighborhood Conservation Department are restructured to form the Community & Workforce Development Department.
  - 1.2.2. This Agreement will be renumbered to CT-CR-20-425, but all terms and conditions, except as amended herein, remain unchanged.
  - 1.2.3. Any reference in the Agreement to Community Services; Community Services, Employment and Training Department; or CSET, will mean Community & Workforce Development Department ("CWD").

#### 1.3 Purpose.

- 1.3.1. County finds that it is in the best interests of the Pima County residents to continue to provide workforce development services to the homeless of Pima County.
- 1.3.2. County has reviewed Awardee's performance of the services and finds it satisfactory.
- 2. <u>TERM and EXTENSIONS</u>, SECTION 1.0. Pursuant to paragraph 1.1, County is exercising the last available extension option. This Agreement will terminate on June 30, 2021.
- 3. SCOPE OF SERVICES, SECTION 2.0, the Commencement Date for the provisions set forth in this Amendment No. 7 is July 1, 2020.
- 4. **COMPENSATION AND PAYMENT**, **SECTION 3.0** is amended as follows:
- 4.1 Paragraph 3.1 is amended to increase "the Maximum Allocated Amount":

- 3.13.2 Awardee must reimburse County for improper, unallowable or unsubstantiated costs discovered as a result of audit or otherwise within thirty (30) days following demand for reimbursement by County.
- 5. EXHIBIT A-1, WORK STATEMENT NO. 3 EMPLOYABILITY SKILLS WORKSHOPS, is amended as follows:
- 5.1 Paragraph 2.1 Workshops is deleted in its entirety and replaced with the following:
  - 2.1. Workshops. Awardee will:
    - 2.1.1. Provide Employability Skills workshops. Each workshop will meet for eighty (80) hours and will follow the curriculum outlined in Awardee's response to RFP-CSET-WS-2015-09 and pursuant to the following:
      - 2.1.1.1. During interruption of site-based services due to COVID-19, Workshops will be provided using on-line platforms. Additionally, one-on-one on-line and phone conferences will be provided, as needed, to assist clients with course work and to prepare résumés.

- 2.1.1.2. Workshops will be conducted at classroom locations determined by CSET, when it is safely possible according to County health officials, as will one-on-one assistance and résumé preparation.
- 2.1.1.3. County will, in its sole discretion, schedule each workshop, determine the workshop format (on-line, in person, or a combination of both) and determine the number of participants for each workshop.
- 2.1.2. Workshops specifically for youth will be open to individuals ages 18 to 24.
- 5.2 **Paragraph 2.2.1** is amended to read:

Hold weekly job search orientations for new SJEC participants. Orientations will be on-line, in person, or a combination of both, as directed by County.

6. EXHIBIT A-2, WORK STATEMENT NO. 4 – EMERGENCY SERVICES MOTEL VOUCHERS, Paragraph 2.1 is amended to decrease the number of motel vouchers provided during the contract year:

FROM: up to one hundred and eighteen (118) unduplicated families and individuals

TO: up to seventy-two (72) unduplicated families and individuals
