Grant provides 75% funding for one police officer. The purpose of this agreement is to enhance law enforcement services concerning gangs and criminal activities through the cooperative efforts of the parties. This action will accept additional funding and continue grant agreement through 6/30/2021.

This IGA is a non-Procurement contract and not subject to Procurement rules.

**\*Program Goals/Predicted Outcomes:**

Enhance law enforcement services concerning vehicle theft through cooperative efforts of the agencies involved.

Collaborate with other area law enforcement agencies - state, local, and federal - to mitigate vehicle thefts in the State.

Monthly reports.
