*Project Title/Description:

U.S. Department of Housing and Urban Development (HUD) Continuum of Care Program - La Casita

*Purpose:

In FY2019-20 HUD awarded \$200,199.00 for Pima County La Casita Transitional Housing Program, which is one of four HUD Continuum of Care housing programs administered by Pima County. The La Casita program provides transitional housing and employment assistance with supportive services to move youth, ages 18-24, who are experiencing homelessness toward self sufficiency.

This amendment is to move \$22,000 from Supportive Services to Rental Assistance. This change will allow the County to provide housing assistance to program participants impacted by COVID-19. No other changes to the project's target population, performance, or outcomes will occur as a result of this amendment.

Indirect cost: No new funding with this amendment. Indirect calculated already.

The negative impact of not approving this amendment is the County would not receive funds for the La Casita program which provides transitional housing and employment assistance with supportive services for youth ages 18-24.

AMENDMENT TO THE CONTINUUM OF CARE PROGRAM GRANT AGREEMENT

This Amendment to Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and Pima County, AZ at 2797 East Ajo Way, Tucson, AZ 85713-6223.

RECITALS

- 1. HUD and the Recipient entered into a Grant Agreement dated April 8, 2019, having Grant No. AZ0032L9T011811.
- 2. The parties are desirous of amending the Grant Agreement to move \$22,000 from Supportive Services to Rental Assistance. This change will allow the Recipient to provide housing assistance to program participants impacted by COVID-19. No other changes to the project's target population, performance, or outcomes will occur as a result of this amendment.
- 3. HUD has determined that the change is necessary to better serve eligible persons within the geographic area and to ensure that awarded funds are fully expended in order to house the greatest number of homeless youth possible through the project.

AGREEMENTS

The Grant Agreement is hereby amended to reduce the Supportive Services by \$22,000 and to increase the Rental Assistance by \$22,000. Paragraph 4 of Exhibit 1, Scope of Work for FY 2018 Competition, shall be replaced with the following:

4. HUD agrees, subject to the terms of this Agreement, to provide the Grant funds for the project application listed below in the amount specified below to be used during the performance period established below. However, no funds for new projects may be drawn down by Recipient until HUD has approved site control pursuant to the Rule and no funds for renewal projects may be drawn down by Recipient before the end date of the project's final operating year under the grant that has been renewed.
