*Project Title/Description:

United States Housing and Urban Development (USHUD) Continuum of Care (CoC) Program - One Stop Rapid Rehousing. The contract and amendments can be found in OnBase by searching Contracts CR-20*467 (formerly CS-18*078) in Doc ID AMS.

*Purpose:

USHUD awarded Pima County \$208,637.00 to provide rapid re-housing and employment services to people experiencing homelessness in order for them to become self-sufficient.

This amendment will provide additional funding and extends the contract with Compass Affordable Housing, Inc., a subrecipient, for another year for the period October 1, 2020 to October 31, 2021.

Compass Affordable Housing will provide at least 15 rental units for eligible households at any given time, up to 24 households per year.

GRANT FUNDING AGREEMENT - AMENDMENT FOUR (4)

1. BACKGROUND AND PURPOSE

- 1.1. <u>Background</u>. On October 3, 2017, Pima County ("County") and Compass Affordable Housing, Inc. ("Awardee"), entered into the above-referenced Agreement to fund Rapid Re-Housing ("RRH"); employment and training assistance; and other necessary supportive services for the homeless throughout Pima County.
- 1.2. County Organization. Effective July 1, 2020:
 - 1.2.1. Pima County Community Services, Employment and Training Department and Pima County Community Development & Neighborhood Conservation Department are restructured to form the Community & Workforce Development Department.
 - 1.2.2. This Agreement will be renumbered to CT-CR-20-467, but all terms and conditions remain unchanged.
 - 1.2.3. Any reference in the Agreement to Community Services; Community Services, Employment and Training Department; or CSET, will mean Community & Workforce Development Department ("CWD").

- 1.3. Purpose.
 - 1.3.1. The United States Housing and Urban Development ("HUD") has awarded County, as Grantee, 2020-2021 Continuum of Care ("COC") Program funds for an additional year of Rapid-Rehousing ("RRH") services to the homeless.
 - 1.3.2. The Pima County Board of Supervisors finds that it is in the best interests of the residents of Pima County to provide an additional year of RRH services for the homeless.
 - 1.3.3. Pursuant to HUD guidelines, Awardee is a "Subrecipient" of these CoC Program funds and will conduct all activities under this Agreement accordingly.
- <u>TERM, EXTENSIONS AND AMENDMENTS</u>, SECTION 1.0, Pursuant to paragraph 1.2, County exercises the third of four (4) available Extension Options. This Agreement will terminate on October 31, 2021.
- 3. <u>SCOPE OF SERVICES</u>, SECTION 2.0. The Commencement Date for the provisions set forth in this Amendment No. 4 is October 1, 2020.
- <u>COMPENSATION AND PAYMENT</u>, SECTION 3.0, paragraph 3.1 is amended to increase the Maximum Allocated Amount:
