*Purpose:

Amendment of Award: Master Agreement MA-PO-16-077, Amendment No. 7. This Amendment extends the contract termination date to 12/13/2021 and adds the annual award amount of \$563,000.00 for a cumulative not-to-exceed contract amount of \$3,302,000.00. Administering Department: Regional Wastewater Reclamation

*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.010 Competitive Sealed Bidding, on December 15, 2015, the Board of Supervisors approved an award of contract for an initial term of one (1) year and an annual award amount of \$390,260.00 with four (4) one-year renewal options.

On October 18, 2016, the Board of Supervisors approved a Ratification of Amendment of Award increasing the annual award amount by \$259,740.00 to \$650,000.00.

On November 17, 2016, the Procurement Director approved Amendment No.2, which extended the termination date to December 14, 2017 and added the annual award amount of \$650,000.00, for a cumulative not-to-exceed contract amount of \$1,300,000.00. Three (3) renewal options remained.

On August 18, 2017, the Procurement Director approved Amendment No. 3, which extended the termination date to December 14, 2018 and added the annual award amount of \$650,000.00, for a cumulative not-to-exceed contract amount of \$1,950,000.00. Two (2) renewal options remained.

On September 13, 2018, the Procurement Director approved Amendment No. 4, which extended the termination date to December 14, 2019 and added the annual award amount of \$650,000.00, for a cumulative not-to-exceed contract amount of \$2,600,000.00. One (1) renewal option remained.

On September 13, 2019, the Procurement Director approved Amendment No. 5, which extended the termination date to December 14, 2020 and added a partial annual award amount of \$84,000.00 for a cumulative not-to-exceed contract amount of \$2,684,000.00. No renewal options remained.

On August 26, 2020, the Procurement Director approved Amendment No. 6, which added a partial annual award amount of \$55,000.00 for a cumulative not-to-exceed contract amount of \$2,739,000.00.

This sixth year extension is required to provide a consistent product for daily operations as a before and after baseline to facilitate testing on the department's NuReSys struvite reduction process which is scheduled from 10/5/20 to 12/5/20.

SUBJECT: Polymer Contract Extension Request - MA #16*077

The current master agreement with Polydyne Inc. is in the final term of the contract and will expire in December of 2020. Due to extenuating circumstances relating to ongoing construction at the Tres Rios WRF in which this product is used, we are requesting a one year extension of this master agreement to provide uninterrupted delivery of product and allow for completion of construction. Ongoing issues that interfere with soliciting a new contract at this time include:

- NuReSys project completion The NuReSys struvite sequestration project is behind schedule resulting from COVID-19 associated material production and delivery delays. Once construction is completed the contractor must demonstrate 90 days of performance testing prior to acceptance.
- Ferric chloride use The NuReSys process will eliminate the post digestion addition of ferric chloride which may also affect the chemistry and consistency of the biosolids.
- COVID 19 The selection process of a polymer requires pilot testing. The on-site testing of the polymer requires technical staff from multiple vendors to be present for extended hours on multiple days.

Polymer is required for daily treatment operations and is used to thicken sludge prior to digestion and biosolids prior to disposal. A consistent quality of biosolids following the commissioning and stabilization of the NuReSys process is necessary before attempting polymer optimization and selection. Due to the process changes indicated above, it is necessary to evaluate vendor polymers to attain consistent quality of the biosolids at the Tres Rios WRF. Delaying procurement solicitation until 2021 will allow sufficient time for project completion, process stabilization and reduce the number of outside vendors on site until the pandemic subsides thereby minimizing possible COVID-19 exposure.
