Requested Board Meeting Date: November 10, 2020

**Title:** Traffic Regulation - Confrey Avenue and Scots Pine Street

### Introduction/Background:

The Pima County Department of Transportation received a citizen request to install a stop sign on Confrey Avenue at Scots Pine Street. Confrey Avenue and Scots Pine Street are both local roadways with a 25 mph posted speed limit. Confrey Avenue terminates at Scots Pine Street at the north end.

### Discussion:

The Pima County Department of Transportation conducted a traffic control study at the Confrey Avenue and Scots Pine Street intersection to determine if a stop sign is recommended to be installed. Field observations determined that the sight visibility at the intersection is limited due to horizontal curvature on Scots Pine Street to the west. No crashes were reported at the intersection in the past five years from 2015-2019.

### Conclusion:

The traffic control study determined that a stop sign is recommended to be installed for northbound Confrey Avenue at Scots Pine Street as a result of the sight visibility limitation.

### Recommendation:

The Pima County Department of Transportation recommends an ordinance be approved to designate Confrey Avenue and Scots Pine Street as a stop intersection with northbound traffic on Confrey Avenue stopping for traffic on Scots Pine Street.

ORDINANCE 2020 - \_\_\_\_\_

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF CONFREY AVENUE AND SCOTS PINE STREET IN PIMA COUNTY, ARIZONA**

**THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:**

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish the intersection of Confrey Avenue and Scots Pine Street as a stop intersection in Pima County, Arizona.

**BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:**

SECTION 1. The intersection of Confrey Avenue and Scots Pine Street shall be designated a stop intersection with northbound traffic on Confrey Avenue stopping for traffic on Scots Pine Street.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
