#### To all attending:

It has come to my attention that this meeting will decide whether or not the contract for Chuck Huckelberry is to be extended. Furthermore, it is to agree to give Mr. Huckleberry a raise.

I have also learned through an OP Ed with Sharon Branson, this past Sunday, that there will no funding for programs that have been on the table for quite some time; namely the Bond Initiative initiated by Mr. Huckleberry last Thanksgiving. I find this ironic and very distasteful that you would agree to giving anyone a raise and deny funding for such essential programs.

Right now, there are 168 active cases of Covid in County jail and spreading daily. Inmates are panicking and guards are growing weary of their jobs as they expose themselves and their families to this deadly virus. Proper PPE is not being provided due to funding and guards are coming in sick because they will lose their pay if they quarantine.

The Bond initiative was agreed to around Thanksgiving. This would have thinned the population of inmates dramatically by releasing bond eligible inmates. Today, there is no possible way to distance inmates or care for them as the covid numbers increase. It is time to make these funds available right now and release even Covid positive cases, if they can be released into a proper home environment to recover and be medically treated.

There should be no pay raises until such funding can be implemented. In fact, as you folks sit there and agree to shut down businesses because this is the right thing to do for others to stop the spread of Covid, causing countless citizens to lose their livelihoods, you should all agree to stop your own salaries so that you can contribute to their needs as they face devastation.

There are many other programs being discussed for implementation, such as mental health and more to reduce inmate population that will save the county tons of money in the long run. There should be no pay raises or renewal of contracts until a logical common sense approach is made with this crisis. We are not talking simply about inmates; we are talking about government employees who are putting their lives and their families' lives at risk because of lack of funding. No, Mr. Huckleberry; do the right thing. Do not take the pay raise until the funding is available for the Bond initiative, proper PPE for inmates and staff at County and

guaranteed pay for those who must quarantine. Further, take the initiative to agree that inmates who are not likely to reoffend be released as well, no matter what their plea is. Lives are at stake. It's time for you, as a public servant to do the right thing. Now. Thank you. Nina Puente

Dear Honorable Board Members,

I am a county employee who has watched my fellow county workers suffer greatly through a mismanagement of the response to COVID-19. Although the Board of Supervisors tried their best to mitigate the effects of this pandemic on the workforce, the denial of key coronavirus risks out of Mr. Huckelberry's office prevented proactive measures such as mask wearing, telework and paid furlough. Many of us are aware of the disdain Mr. Huckelberry holds for the people who work for this county which became extremely evident with disparaging statements about working from home and a recent screed about lawyers with the Public Defender's office not having work.

News travels fact, and we all know that Mr. Huckelberry continues to go out to lunches with staff and not wear masks. Although his inner circle of loyalty hires are well-paid and respected, the rest of us are treated as expendable and not worth exploring pandemic mitigation efforts or even providing a worker's safety plan for positions at especially high risk of transmission. Many, many of us are simply afraid to speak out because we are worried about Mr. Huckelberry's wrath, or that of his inner circle.

Put plainly, Mr. Huckelberry has done great things for the county, but he is not reflective of the administrative needs that these times call for. Specifically, we need an Administrator who is more open to telework, is less interested in consolidating power and more interested in protecting workers, allows medical science to guide decisions and empowers workers rather than micromanages them.

I respectfully suggest a month-long extension of his contract to allow more time for public discussion and a commission formed from different levels of county workers to freely and openly speak to the Board about their concerns without a middleman or filter. A six-month long extension of his contract after this time can be used to recruit for a replacement. Ultimately, we need a new administrator, be it someone from outside the county or someone promoted within, but preferably someone who is vetted by the county worker commission and the Board of Supervisors.

Dear Mr. Scott:

I am writing to you to express my displeasure regarding the Pima County Administrator's request for his raise package for 2021 for a new term. The timing of his request could NOT be worse. The Pima County Administrator outlined in his 2020 budget memorandum to County Staff that there was the distinct possibility that the county would find itself in a less than fluid position due to the lack of revenue's of the bed tax among others due to Covid. He went on to say that he was asking each department in the county to submit furlough or staff that could be identified as non-essential if, God forbid, it came to layoffs. This is the same individual who has for years promised the County residents he would hear the multitude of complaints and fix our roads, which to date many are in deplorable condition.

I have worked for several years in the Government sector, both at a federal level and after that a local level. I cannot believe he would submit this request to the Board since three of you have yet to be sworn into office. I can only surmise that he hopes that the Board will approve it without public comment (or in this case outcry) and hope that he will get a quorum of supervisors to approve his salary package.

I have friends who have tested positive for the COVID virus, several of which have had to be hospitalized or have had long term severe health concerns that they are still fighting as a result of this virus. I am very fortunate that I have been able to stay gainfully employed and continued to receive a paycheck throughout this time frame. I do know some current county employees who are currently under the quarantine protocol and who I am sure are wondering "what if" should they run out of sick leave, annual leave or the covid leave banks set forth by their employer.

I can truly sympathize with the anonymous employees of the county who were reportedly interviewed for the KGUN-9 news story that appeared on-line today.

Given the terrible optics, the fact that the County Administrator reportedly the DAY BEFORE asked for additional CARES funding stating that "we are simply out of funding to respond to the pandemic" it is abhorrent to me to even consider his request for a raise. Residents of the county are wondering where their next meal is coming from, straining tight budgets to stay home with school -age children who have gone back to distant learning, or have been let go from their job as many small businesses in our community have been forced to close as a result of the virus.

In closing, I sincerely hope that you will have the courage to say "NO" to Mr. Huckelberry's raise request and perhaps direct his salary increase package to help the small businesses, those facing eviction or one of the many community service agencies who are truly struggling to stay open to assist those less fortunate.

Dear Board of Supervisors,

Concerning Addendum # 5, the Contract for Pima County Administrator Chuck Huckleberry, how can you give someone a contract with a raise when there is a hiring freeze and many employees are forced to take their pandemic leave and use their sick and vacation time, or to take leave and collect unemployment?

He makes up his own contract and then you approve it without discussion or questions.

Why does a contracted employee get a raise (salary adjustment) when other non-contracted employees do? He's already received a raise with every contract, every four years. Last contract was \$288,000 and he got an additional \$14,000 to \$302,000, now he wants an additional \$13,000 to \$315,000 base salary. At 2080 annual hours, his rate is \$151.44 per hour.

Why does he get an additional 240 hours (6 weeks) of sick and vacation time - \$36,345.60, on top of the eligible 5 to 6 weeks? And if he doesn't use it, he gets it paid out. (He doesn't use it). Also, additional paid leave to serve on public, professional, advisory and fiduciary boards and organizations.

Why does he get an additional payment of \$26,000 for Deferred Compensation and max to 401a plan \$15,000, per year. Also, Health Savings Plan \$ 8,200 per year, other employees get \$500 or \$1000 per year, depending on if they cover their families too.

In my 19 years as a county employee I have never felt as insulted or disrespected as I have these past 10 months. Mr Huckelberry's baseless and disparaging comments about County workers not being trustworthy enough to telecommute, followed by demanding as many people return to County buildings as possible (seemingly disregarding the risks of COVID-19 transmission in enclosed spaces) made it very clear to County employees that he was not taking our safety or that of our families into consideration.

Most recently, Mr Huckelberry's decision to enforce a "stay at home" effort proved to be confusing for County residents in need of County resources who visited various departments' buildings only to find them closed. It also forced scores of employees to take personal leave accruals if they had it while they worked part time, or receive half (or less than half) of their expected pay during the holiday season. To claim we are "mitigating risk" for employees while not even acknowledging that so many of us would be greatly impacted by this unplanned financial loss was not only inconsiderate but extremely dismissive and out of touch. His justification for this stay at home order (and no plan to provide compensation) only further proves his level of disconnect: His claim that this order wouldn't have much of an impact on staff because so many would be taking vacation during the holidays assumed that anyone had any time left after many personal leave banks were depleted during the first stay at home order (when he refused to consider the vast majority of viable telecommute requests.) Time and time again, we as employees have had to choose between our health and our financial stability, regardless of how high-risk we or our household members may be when it comes to a potential covid exposure.

Lastly, Pima County residents are very aware of Mr Huckleberry's annual salary in comparison to people in similar positions throughout the country, regardless of the vast differences in costs of living. Giving him yet another raise at a time like this could prove

disastrous to new board members hoping to earn the trust of their constituents. Please rethink this request. Thank you for considering.
