Many Tucsonans, Arizonans, and people across the country have read about the the memorandum before the board of supervisors regarding a 5% raise increase for an already \$302,000 per year salary. I implore Mr. Huckelberry to drive around Tucson, from Oracle to Vail and look around, look at the overwhelming majority of families who are barely making it, especially now that this pandemic has wiped out a town made on small businesses. My grandmother has been taking care of foster children for 3 decades here in Tucson and every year it's more horrifying, yet Mr. huckelberry knows nothing of that.
