To the Board of Supervisors:

I am writing you today as a fellow county employee who works in this very building. For obvious reasons I feel the need to remain anonymous.

It is inconceivable to me that you would seriously consider reinstating the county administrator for yet another 4 years, and giving him any more money, much less a 4 percent raise.

I have seen over the years a total disregard for the rank and file employees. Whenever we need a much deserved raise ourselves we are told "it's not in the budget". Yet it is somehow in the budget to give someone who is already the highest paid county administrator in the country (with the exception of Los Angeles' county which is 10 times bigger) a 4 percent raise on top of what he already makes? This at a time when we are in a global pandemic and businesses and ordinary citizens are hurting badly, and in too many cases perishing due to this virus.

In a recent board meeting Mr. Huckleberry was asked if everyone who could work from home during this pandemic was being allowed to do so. He said yes. That was a lie. I am perfectly able to work from home but have not been given the right to do so since this pandemic began last March. Even though it clearly puts me and others at risk, and the people I live with who are in an extremely high risk category.

There are others besides me who are able to work from home but have not been given the right either. The fact is Mr. Huckleberry has never really wanted to allow any employee to work from home. He apparently does not trust his employees to do so. This pandemic has forced him to do so to keep county operations functioning at a minimum level, so he picks and chooses who he thinks he can "trust" and the rest are apparently supposed to take the risk of getting sick and god forbid die.

Beyond the pandemic, and another example of not being concerned for the employees is the need for fire-safe rooms on all of the floors of this very building you are sitting in today. Only a few of the floors have fire-safe rooms for refuge, but many do not, and we have been told we had to make due with sheltering in a non-fire safe area or non-fire protected conference room until help arrives. Would the county administrator consider allocating some of his considerable salary to provide safety for his employees he claims to care so much about? Or just ask for another 4 percent for himself?
