Requested Board Meeting Date: February 16, 2021

Title: Yield Regulation - Twilight Echo Road and Echo Crossing Road

Introduction/Background:

The Pima County Department of Transportation received an internal request to install stop or yield signs at the four-legged intersection of Twilight Echo Road and Echo Crossing Road. Twilight Echo Road and Echo Crossing Road are both local roadways with a posted speed limit of 25 mph.

Discussion:

Pima County Department of Transportation staff conducted a traffic control study at the Twilight Echo Road and Echo Crossing Road intersection as a result of the request. No sight visibility restrictions were observed at the intersection and no crashes were reported in the past five years from 2015 to 2019.

Conclusion:

The traffic control study determined that yield signs are recommended to be installed for northbound and southbound Twilight Echo Road at Echo Crossing Road to establish right-of-way at the four-legged intersection.

Recommendation:

The Pima County Department of Transportation recommends an ordinance be approved to designate Twilight Echo Road and Echo Crossing Road as a yield intersection with traffic on Twilight Echo Road yielding to traffic on Echo Crossing Road.

ORDINANCE 2021 - _____

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF TWILIGHT ECHO ROAD AND ECHO CROSSING ROAD IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627 and 28-855 as amended, to designate and establish yield intersections and to erect yield signs.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish the intersection of Twilight Echo Road and Echo Crossing Road as a yield intersection in Pima County, Arizona.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. The intersection of Twilight Echo Road and Echo Crossing Road be designated a yield intersection with traffic on Twilight Echo Road yielding to traffic on Echo Crossing Road.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
