Title: Speed Regulation - Pima Mine Road

#### Introduction/Background:

The Pima County Department of Transportation received a constituent request to increase the 40 mph posted speed limit on Pima Mine Road west of Interstate 19 following recently completed pavement repair. This segment of Pima Mine Road provides mine access and terminates at the west end.

#### Discussion:

The Pima County Department of Transportation conducted a speed study as a result of the request. The speed limit on Pima Mine Road west of Interstate 19 was reduced to 40 mph in 2010 as the roughness of the road was not conducive to a higher speed limit.

#### Conclusion:

The Pima County Department of Transportation recommends the posted speed limit on Pima Mine Road west of Interstate 19 be increased from 40 mph to 50 mph based on field observations, data review and the speed study results. The Pima County Sheriff's Department provided concurrence with the speed limit increase.

#### Recommendation:

**Fiscal Impact:** 

The Pima County Department of Transportation recommends Ordinance 2010-36 be repealed and a 50 mph speed limit be established on Pima Mine Road from 3 miles west of Mineral Hill Road to the Town of Sahuarita Limits.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; ESTABLISHING REASONABLE AND PRUDENT SPEED LIMITS FOR MOTOR VEHICLES ON PIMA MINE ROAD IN PIMA COUNTY, ARIZONA

#### THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627, 28-701 and 28-703 to fix reasonable and prudent speed limits on a through County highway.
- 2. The Board of Supervisors has determined a reasonable and prudent speed limit for motor vehicles on Pima Mine Road in Pima County.

### BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA.

SECTION 1. The following speed limit is established as reasonable and prudent speed limit for Pima Mine Road in Pima County:

<u>SPEED</u> <u>FROM</u> <u>TO</u>
50 mph 3 miles west of Mineral Hill Road Town of Sahuarita Limits

SECTION 2. Ordinance 2010-36 is repealed, and other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This Ordinance takes effect when and to the extent that signs are posted on the highway listed in Section 1 of this Ordinance, giving notice of the new speed limit, but in no event earlier than 30 days from the date of adoption of this Ordinance.

SECTION 4. Violators of this ordinance shall be subject to civil and criminal sanctions as provided by law.

SECTION 5. The various County officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this Ordinance.

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING PRIMA FACIE REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON PIMA MINE ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Pima Mine Road,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The reasonable and safe prima facie speed limit on Pima Mine Road be established as follows:

SPE	EED LIMIT	<u>FROM</u>	<u>TO.</u>
a)	40 mph	3.00 miles west of Mineral Hill Road	Town of Sahuarita Limits

**SECTION 2.** Ordinance 1992-099 Section 300 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.
