**CONTRACT AMENDMENT**

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

1.1. Background. On March 01, 2016, County and Contractor entered into the above referenced agreement to establish a formal framework for the Friends of Agua Caliente Park and Pima County to partner on coordinated and cooperative fundraising, park conservation and park management activities.

1.2. Purpose. County and Contractor would like to extend the term of the current contract for an additional five years for the purpose of continuing their joint efforts to provide additional funding that will augment established programs, facility operation, and maintenance of the historic buildings and ponds.

**2. Term.** The parties agree to extend the contract term for five additional years commencing on March 1, 2021 and terminating on March 1, 2026. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.

**3. Termination for Convenience.** Either party may terminate this agreement with 30 days notice to the other party.

**4. Israel Boycott Certification.** Pursuant to A.R.S. § 35-393.01, if Contractor engages in for-profit activity and has 10 or more employees, and if this Contract has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Contract to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
