Dear Board of Supervisors,

In my 40+ years of experience in policing, 21 as a police chief, I have come to appreciate the value of high-quality early childhood programs. For the past 10 years, I have been involved in *Fight Crime: Invest in Kids*, an organization of over 5,000 law enforcement leaders which recognizes the critical importance of making high-quality early care and education available to kids from birth to age five from families with low incomes.

I would like to join with Tucson's *Child and Family Resources, Inc.* in encouraging you to support the measure on your February 16<sup>th</sup> agenda directing the County Administrator and county staff to include \$10 million in the Pima County budget for Fiscal Year 2021-22 to fund scholarships to wholly or partly cover the cost incurred by parents who wish to enroll their three- or four-year-old child in a high-quality early childhood program. Eligible children will come from families whose income is under 200% of the federal poverty level. These scholarships would be payable only to highquality early childhood education programs such as those run by public-school districts, childcare centers, and family home care providers.

Those of us in policing know that giving kids the right start in life can prevent later crime, as shown by several rigorous studies. In the first few years of life, children's intellect, emotions, and their ability to develop concern for others are building the foundation upon which their later success or failure will greatly depend. Voluntary early education and care for babies, toddlers, and preschoolers can put kids on the path towards success and steer them away from later crime.

One example of this is Chicago's publicly funded Child-Parent Centers, which have served over 100,000 three and fouryear-olds since 1967. Researchers followed a sample of participants up until age 28 and found that children who did not participate were 70 percent more likely to be arrested for a violent crime by age 18. Those who participated had a 29 percent increase in high school graduation rate. A recent study of Oklahoma's universal pre-K program found the program decreased the likelihood that Black children were later charged with a misdemeanor or felony crime at age 18 or 19.

When we fail to invest effectively in our children, everyone pays the price—in taxes for criminal justice costs, costs to business, and costs to the victims. Worse, some children and adults will pay with their lives. Investing now in what works not only saves lives and protects our community, it saves money. Researcher Mark Cohen estimated that the average value of preventing a baby from growing up to become a youth who drops out of school, uses drugs, and goes on to engage in criminal behavior is at least \$2.5 million per individual.

Thank you helping us reduce crime and improve the lives of many children in our community by supporting this important measure.

Now, working in the non-profit sector for early childhood education, I see the impact of preschools and childcare centers.

Please support this - our children are our future. It is our duty to make every effort to help them succeed.

Assistant, Board Member Erik Hite Foundation I am taking opportunity to address the importance of access to high quality Pre-K education and to request your support of this issue in the coming fiscal year budget. I urge you to appropriate \$10m to be used in the form of scholarships to 3 and 4-year-old children.

I have been a child clinical psychologist for more than forty years, most of that time in Tucson. I served as head of behavioral health services for Thomas-Davis Medical Centers and developed and directed Catalina Behavioral Health Services. I taught as a special education teacher for the Amphitheater School District for 3 years and, and later worked for Community Partnership of Southern Arizona. In that capacity I managed the development and construction of Pima County's Crisis Response Center.

I urge invest in broadened access for 3 and 4 year olds to high quality Pre-K education. From development psychology perspective, two of the most important areas of skill growth for 3 and 4 year olds are language skills and social skills. Where 2 year olds general speak in 2-4 word sentences, 3 and 4 year old often speak in paragraphs! I'm certain you have all been amazed at the seemingly daily growth of language skills in this age group. This successful development depends on a child being exposed to others who use a broad vocabulary and adult sentence structure. Failure to have these experiences can result in a life-long retardation of verbal skill development.

Three-year-olds also begin to focus on adults and children outside their family. This is the time when the concepts of friendship, sharing, and taking turns. It is the time when children first want to please friends, be like their friends and learn to "follow rules". It's the time when the foundation for self esteem is laid and empathy starts to develop. High quality Pre-K is an ideal\_opportunity to teach children how to manage their emotions and problem solve when they are upset rather than deal with their world by having temper tantrums. It's also a crucial period in the development of resiliency. At 3 and 4 years old, their interactions with those around them will help to shape their personality and their ways of thinking. The potential impact of high quality Pre-K on social skill development and future success is enormous.

Between 8 months and 3years old children's brains are particularly adept at becoming multilingual; therefore, children raised in monolingual households will get a particular boost from the proposed access to high quality early childhood education.

Additionally high quality Pre-K at 3 years of age provides the opportunity for skilled staff to spot developmental delays or disability direct families to available resources thereby accelerating remediation.

As you well know, the more vulnerable a child's circumstances, the more likely and extensive the impact of high quality Pre-K. Not only will children who are afforded this opportunity have an enhanced likelihood of academic and social success, they are less likely to require special time and attention from teachers and others as they mature. This allows teachers and others to spend more time with the class as a whole and improves the academic experience for all. Again, thank you for your service to our community and for your willingness to join with the community, public and private education institutions, business leaders and law enforcement to invest in this all important, high quality Pre-K education program.
