

To: Pima County Board of Supervisors

February 12, 2021

I support The Preschool Promise and urge the Pima County Board of Supervisors to appropriate \$10m in the coming fiscal year for support of high-quality early childhood education in the form of scholarships to 3 and 4 -year-old children. A minimum 3-year funding commitment is requested in order to show the quality early learning community that investment in system restoration and expansion will be met by on-going support.

Virtually everybody agrees on the value of high-quality early education as a preparation for success in kindergarten. High-quality early childhood experiences mean that a child is more likely to succeed in school and in life. And that means not only better lives for these future adults, but significant savings for taxpayers.

Before the pandemic, fewer than 20% of the children in our community attended high quality preschool. High quality early education costs approximately \$10,000 per child per year and cost is the primary barrier.

Financial support to send their children to high quality early education is crucial to parents' ability to work. Without support, some families will be forced to place their young children in low-quality, perhaps even dangerous, care settings. Without access to high-quality safe childcare options some workers, mainly women, will be forced to remain out of the work force altogether. Children will lose the educational and life benefits of early education, families will suffer, and many childcare businesses will be closed permanently. If families cannot afford this high-quality childcare, there will be no recovery.

Please make this investment in our children, our families, our businesses, our community, and the future we share.
