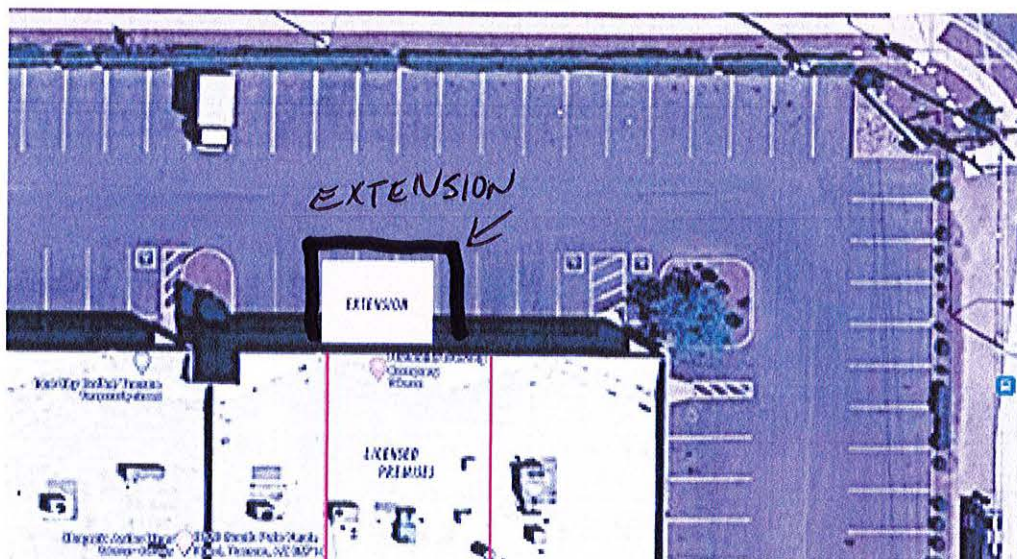

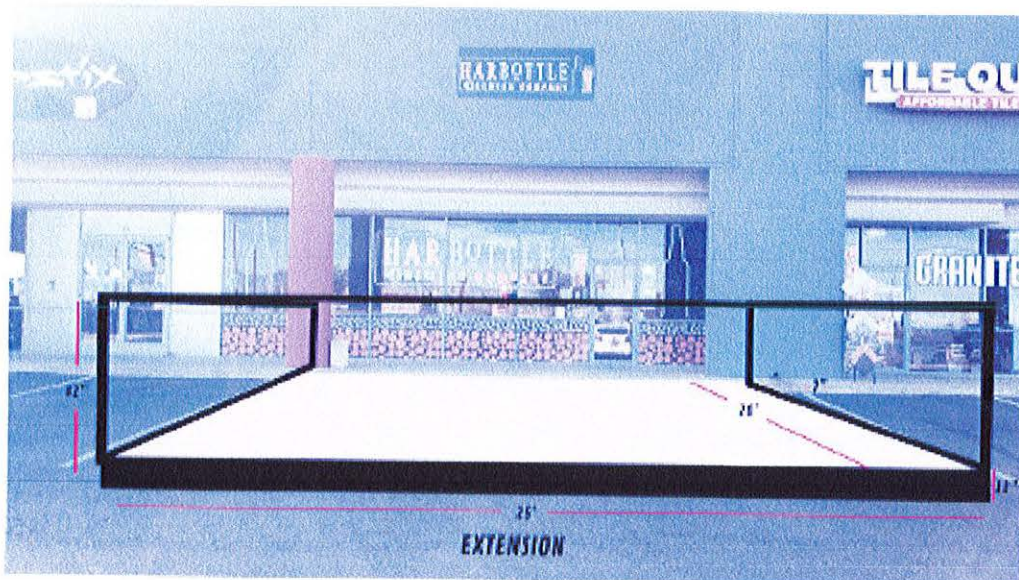
East View


