The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

1.1. <u>Background</u>. On March 7, 2016, County and Contractor entered into the above referenced agreement to provide as-needed legal advice to, and legal representation on behalf of, the Pima County Sherriff's Department concerning the release of public records and other information and restrictions that might be applicable to the Sheriff and his deputies with respect to pretrial and trial publicity in criminal cases and related matters.

1.2. <u>Purpose</u>. County requires additional time to continue having this service available.

2. Term. The parties agree to extend the contract term for one additional year commencing on March 7, 2021 and terminating on March 6, 2022. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.
