Re: COVID-19 Update for the April 20, 2021 Board of Supervisors Meeting

We continue to monitor the number of COVID-19 infections occurring within the community over the last five weeks.

We are now in a vaccination transition point. In the past, demand for vaccinations exceeded vaccine supply. Today, we are seeing a drop off of demand for vaccinations, possibly to the point where vaccine supply will exceed demand. I previously indicated we have analysis underway to determine the reason there appears to be vaccine hesitancy and will attempt to encourage vaccination as well as remove artificial barriers.

In the meantime, Attachment 1 shows the total number of vaccines administered by facility and organization. In total, for the period ending April 7, 2021, 589,584 vaccines have been applied, most through County regional vaccination centers as well as the State's University of Arizona facility.

We have also added two regional vaccination centers that do not show up in the attached data, the El Pueblo Community Center and the Kino Event Center. Both are now operational and will be accounted for in future vaccine reports. While reservations are being taken for vaccination appointments, most of our regional sites are also open to walk in registration making it much easier to receive a vaccination.

We also continue to be successful in mobile clinics reaching various locations throughout the community, including disadvantaged and minority populations. Attachment 2 is a list of sites that have been administered through our contactor, Premier Medical Group. A total of 47 mobile clinics have been provided through April 11, 2021. The total number of vaccines administered through our mobile clinics are now 17,407. The only mobile clinic that has been

disappointing as far as turnout has been the one held at Amphitheater High School on April 11, 2021 where only 80 vaccines were administered. We will continue to develop strategies to increase improved access to achieve vaccine equity within the community.

We recently received our first draft Intergovernmental Agreement from the Arizona Department of Health Services (ADHS) for the federal point of distribution (POD). Yesterday, we met with ADHS officials to discuss the agreement and will meet today with both ADHS and Federal Emergency Management Agency (FEMA) officials. Hopefully, we can reach an agreement on the language proposed, at this time it is very different from the language I have previously shared with the Board. We are uncertain as to the actual implementation of the federal POD, but it is likely it will be open the third or fourth week of April. More information will be provided on this federal POD when specific information has been developed.
