I am requesting the Board if Supervisors approve item 7 on the Consent Calendar Knott Development inc. pre development services agreement for Kino South Sports and Entertainment Complex. I have been involved with the youth hockey group for over 5 years now as a grandparent to currently 3 hockey players ages 19, 9 and 6 and soon adding a fourth grandchild to the program. It is past time for Pima County and Tucson to build an ice rink facility. Youth hockey has grown tremendously over the last 5 years and we need dedicated ice for not only youth hockey but adult hockey, figure skating and other ice skating sports. The Tucson area is the largest metropolitan area that does not have at least one sheet of dedicated year-round ice. Our program has outgrown the Tucson Convention Center's available ice time with no opportunity for additional ice time. I truly believe that this development will not only provide a viable facility for ice sports but also a positive economic benefit to the area. Many families are traveling to Phoenix just for ice time as well as tournaments in El Paso Texas, Flagstaff, Mesa, Chandler, Glendale and Scottsdale. This community can support this facility as shown by the growth of the hockey programs as well as the tremendous attendance at the temporary outdoor ice rink downtown in 2019.
