I am honored to serve as the President for the JobPath Board of Directors. I became aware of the organization when I was asked to give a presentation about my career to some high school students as part of the outreach program for NASA'S OSIRIS-REx mission. Following that presentation, I realized one of my co-workers was active on the Board of Directors and I started to learn more about the organization. I chose to increase my involvement because I, like many of the Directors, agreed with the mission of the organization. We say that we change paths and change lives. I have witnessed that in my time with the organization.

I want to remind you of some of the statistics of the program. JobPath has a strong reputation in our community with outcomes that make a difference for entire families. Prior to the Pandemic, in 2019, 90% of JobPath students were graduated from their programs of study. 85% of the graduates got a job in their field within 6 months of graduating. Those students saw an increase in their annual salaries of \$42,200. In 2020, during the Pandemic, JobPath was identified by Pima County to help distribute CARES Act Funds to those who were impacted by the pandemic. The nearly \$750,000 provided by CARES stabilized the lives of students and the community by ensuring that rents were paid, ebooks and distance learning technology was available, and that the students could continue their courses of study. As many of our students are getting their education in 'essential' fields, the progress of the students was vital for the community's health and stability.

We are now asking for an increase in funding this year to \$1.75M in hopes that we can continue the work this community needs.

I personally have known that everyone needs a little help from time to time. I received scholarships and support that enabled my education and career. Our students find us because they are actively working to better themselves and need assistance navigating through the academic and professional worlds. Our program gives financial support while also creating communities of people to form study groups, mentorship, and personally tailored guidance to overcome the barriers to completing education. This program has yielded dividends in the past, but it has been COVID that exposed all Americans to how fragile stability can be. The students that complete our program have worked their way off of public assistance to provide for themselves, their families and serve as examples to their communities that success and stability is possible.

Coming out of COVID, JobPath has been asked to expand our program in terms of services offered and the number of participants we serve. The funding that we are requesting will enable that growth that is so vital to the community. Your support will enable JobPath's ongoing project to create economic opportunities for women and parents displaced from the workforce because of COVID-19. This project will lead to sustainable careers that bolster the economic recovery in Pima County, AZ.
