They are the very definition of "first responders", as other paramedic and fire response is remote. In addition to the residents on the mountain, we have numerous visitors that consider the mountain their playground and escape from the desert heat. The MLFD responds to many accidents on the General Hitchcock Highway and other injuries, and are the fastest response to fires. Cabin fires and forest fires are a continual threat. My family lost our cabin in the Aspen Fire and had a very close call with the Bighorn fire last year. Without the MLFD other, small fires could be the next conflagration. It is our understanding that you have an item on the May 4th agenda that should be a welcome departure from decisions influenced by party lines. Continuing and increasing the AGA agreement to support the Mt Lemmon Fire Department for the next 5 years will have a positive impact on all the citizens in our county.

Over 1 million people visit Mt. Lemmon in any given year and most are able to make that trip safely. Those who aren't as lucky have emergency services available in the form of the MLFD. 90% of their calls are to support visitors as opposed to the homeowners whose tax dollars fund the department. A recent drop in the tax valuations has resulted in a decrease in revenue without a compensating decrease in need. Lower property tax valuations aren't going to result in less visitors or less need.

Without additional support from the county, cuts will have to be made that are a detriment to the departments ability to attract and retain well trained personnel and deferred maintenance on equipment. Anyone who has seen some of the videos showing the MLFD responding to the Big Horn fire last year or is aware of the invaluable local and geographic knowledge they provided the Type One Incident Team during that fire couldn't possibly consider cutting compensation to that department.

We are aware that tax revenue reductions as a result of the pandemic and other issues will create budget challenges for the county in the upcoming years and difficult decisions will have to be made, but the MLFD department desperately needs this continued and expanded funding in order to achieve it's mission; one that speaks to the needs of all our citizens.
