I am a 20-year resident of District One, past President of the JobPath Board of Directors and a registered nurse with over 25 years of senior leadership experience in the Tucson hospital and healthcare community. I have with over 25 years of senior leadership experience in the Tucson hospital and healthcare community. I have served in Chief Nursing Officer, Chief Operating Officer and Chief Executive Officer roles during those 25 years of Tucson healthcare leadership service. Today, I am writing this email in support of JobPath's current request for \$1.75M in funding from Pima County's General Fund.

In my 14+ years of involvement with JobPath and during my Tucson nursing leadership employment, I became fully aware and appreciative of the strong economic impact that JobPath's graduates bring to our community. In fiscal year 2019, that impact was estimated at \$17.6 million, driven largely by an increase in annual direct wages of \$3.4 million for JobPath graduates (average starting salary of \$50K per graduate).

With support from JobPath, low-income adults are able to overcome life's challenges to succeed in various certification and degree programs. This success is particularly impactful to the Tucson healthcare community. As we're all acutely aware, the pandemic has increased the demand for future healthcare providers and, to this end, the benefit that JobPath brings to our community is great. Many of the graduates enter the nursing profession - thanks to the support of JobPath, over 90% of JobPath students graduate and 85% are able to secure a job in their new profession within 6 months of graduation. Those numbers are strong, have been consistent since JobPath began and speak to the strength of this valuable community organization.

Thank you very much for your past investments in JobPath, which have enabled hundreds of low-income students to obtain high paying jobs that are in demand at our local employers in the health care, aviation technology and trades. Especially this last year, we have seen the crucial importance of healthcare professionals in treating COVID patients. Most recent data shows that almost 60% of the jobs filled by JobPath students were in the Nursing, Respiratory and Radiology sectors.
