Here is why I ask you to drop all county mask mandates:

- 1. I am vaccinated, and everyone who wants the vaccine now can get it. The government health department encourages everyone to get the vaccine. The government would not promote the vaccine if it was not effective. If the vaccine is effective, masks are unnecessary.
- 2. If there remains a substantial risk of infection post-vaccine, the government would say so. It has not said so. Insubstantial risk is no reason to treat vaccinated people as if they are not vaccinated.
- 3. There is no reason why post-vaccinated people need to wear a mask to protect unvaccinated people. My name is Mariel Ramos and I reside at 5440 W Opuntia Ln Marana, AZ 85658. I am writing this email with the intent of expressing my concern for the ongoing mask mandate.

To begin, research has shown that masks do not stop the spread of SARS-CoV-2 and below are few studies with links provided supporting this claim, beginning with the NIH.

According to the Association of American Physicians and Surgeons, the particle size of COVID-19 is 0.125 micrometers/microns. For any respiratory protection respirator or mask to be highly effective in preventing the transmission, it must provide a high level of filtration and fit. As we know, most people who wear N96 masks are not wearing them properly, hence they are not effective in protecting against COVID.

Surgical masks are loose-fitting devices that were designed to be worn by medical personnel to protect accidental contamination of patient wounds, and to protect the wearer against splashes or sprays of bodily fluids. They aren't effective at blocking particles smaller than 100 microns. A properly fitted N95 will block 95% of tiny air particles down to 0.3 microns from reaching the wearer's face. As stated above, COVID-19 particle size is .125 microns. Surgical masks are also ineffective.

All the cloth masks and materials had near zero efficiency at 0.3 microns, a particle size that easily penetrates into the lung. It's obvious that mask wearing by the general population is proven ineffective at stopping or reducing the spread of

For our youth, studies have shown that mask-wearing for the remainder of the school year could reduce the transmission by 1.1% at best (and this was a study that included adults, not children who do not know how to use masks properly to begin with). https://www.cdc.gov/mmwr/volumes/70/wr/mm7010e3.htm

Let's take a look at the side effects from prolonged mask wearing. The CDC has performed numerous studies that confirm that masks can cause serious health problems, and it states in black and white the side-effects of wearing a mask, specifically related to the masks trapping carbon dioxide or CO2. This particulate study shows that masks cause breathing resistance that could result in a reduction in the frequency and depth of breathing, known as hypoventilation, in as little as an hour of wearing a mask. This particular study is in reference to healthcare workers however, it can also be applied to those who work long shifts at a restaurant or grocery store. Here is a short list of side effects provided on the cdc website: https://blogs.cdc.gov/niosh-science-blog/2020/06/10/ppe-burden/

- 1. Headache;
- 2. Increased pressure inside the skull;
- 3. Nervous system changes (e.g., increased pain threshold, reduction in cognition altered judgement, decreased situational awareness, difficulty coordinating sensory or cognitive, abilities and motor activity, decreased visual acuity, widespread activation of the sympathetic nervous system that can oppose the direct effects of CO2 on the heart and blood vessels);
- 4. Increased breathing frequency;
- 5. Increased "work of breathing", which is result of breathing through a filter medium;
- 6. Cardiovascular effects (e.g., diminished cardiac contractility, vasodilation of peripheral blood vessels);
- 7. Reduced tolerance to lighter workloads.

The studies shared in this email don't even include the horrible delays we're seeing in our little one's speech, or the teenager who's using the mask to hide their face because they're embarrassed or ashamed of how they look.
