Title: Tax Sale (TS-0032 Timberline Land and Cattle) Lot 378 of Diamond Bell Ranch Tucson Unit 7

Introduction/Background:

Resolution for the sale of land conveyed to the State of Arizona under a Treasurer's Deed, to John and Beverly Stoliker.

Discussion:

On October 22, 2019, tax parcel 301-65-3780 (the "Property") was conveyed by Treasurer's Deed to the State of Arizona due to outstanding delinquent taxes. The Property is an approximately 1.1 acre site of vacant land located in the Diamond Bell Ranch Tucson Unit 7 subdivision. The sale of the Property is pursuant to ARS 42-18303, to the highest bidder, which is John and Beverly Stoliker.

Conclusion:

The Pima County Treasurer's office will receive revenue for Property conveyed to the state for delinquent taxes, and the Property will be restored to the tax roll.

Recommendation:

It is recommended that the Board of Supervisors approve the Resolution authorizing the sale of the Property to John and Beverly Stoliker

Fiscal Impact:

Pima County Treasurer will receive funds for property that has been conveyed to the State for delinquent taxes consisting of a sales price of \$4,300.00, plus an administrative fee to Real Property Services of \$1,000.00, for a total of \$5,300.00.

That the Pima County Treasurer is hereby directed to strike from the tax rolls all outstanding property taxes now due and owing on the Property


