I am a Geriatric/Family physician who has practiced my entire career in Pima County.

As my mother once said to me, "You have to spend money to make money". The corollary of that in this situation, is that sometimes you need to spend money to save money.

This is what I mean. I have seen on too many occasions, my geriatric patients being discharged from the hospital with no one at home to assist in there care. Simple things such as help with transfers from laying to sitting, or helping them with their pills can turn into very dangerous and expensive problems. The result is that they fall, or take their meds incorrectly and end back up in the hospital. Many of these patients are "county" patients, and this responsibility falls then to the county coffers, and the bills for their subsequent hospitalization will dwarf the care of this program.

My mother was fortunate (she recently passed away, but she had the means to live in a facility where she had help), but many of our elderly citizens aren't so lucky. This program is a step forward to both humane care for our community, and sound fiscal planning.

I urge you to do as I personally have done, and support the Pima Council on Aging



As a social worker and psychotherapist for many years, I've seen, over and over, the difference for people who have <u>even one</u> person they're regularly around and those who live alone without regular human contact. If someone has a physical difficulty that makes it harder for them to get out, the feelings of isolation, and potential depression, are often decreased by having <u>even one</u> <u>someone</u>, regularly in their life.

Home Sharing is an affordable option that has the potential to solve physical, emotional and financial challenges. Having a structure to help people find these opportunities and help them choose a good home sharing match that most fits their situation and personality, is very helpful. I believe that many people could benefit from well matched home sharing situations, but would find the effort to create them by themselves to be too much. Having a program that spreads the word about these options, gives people a structure to explore and set up the home sharing situations, can help facilitate successful matching and positive outcomes.

It's also an excellent way to help older people stay "home" rather than having to go to congregate living facilities. We have learned well, in this last year, how the ability to stay "home" can mean life or death for an older person.

I whole heartedly support the Home Sharing idea, in general, and this particular Home Sharing Pilot.
