*Purpose:

Pima County receives federal funds from the Department of Economic Security that includes Short Term Crisis Services/Temporary Assistance To Needy Families (STCS/TANF), Low Income Home Energy Assistance Program (LIHEAP), and Community Services Block Grant (CSBG) for Emergency Services Network (ESN) and the other programs for ESN. The County allocates the funds for eligible low-income households experiencing a temporary financial crisis in order to prevent homelessness or utility disconnection. This ADES Intergovernmental Agreement (IGA) Amendment is to revise funding allocations for the period of July 1, 2021 through June 30, 2022 that includes CARES funding and carryover from FY2021.

THE PARTIES AGREE TO THE FOLLOWING AMENDMENT

Pursuant to the Intergovernmental Agreement (IGA) Section 28.0 Levels of Service, the purpose of this Amendment is to add the initial Case Management Service Budget and the Community Services Service Budget for the period of July 1, 2021 through June 30, 2022.

In accordance with the Alert issued on April 2, 2021 the initial allocations are as follows:

The Case Management Intake service reimbursement ceiling for the period of July 1, 2021 through June 30, 2022 is \$233,521.00.

The Case Management service reimbursement ceiling for the period of July 1, 2021 through June 30, 2022 is \$4,074,324.

The Community Services service reimbursement ceiling for the period of July 1, 2021 through June 30, 2022 is \$815,539.

The Cares Act Estimated Carryover amounts are as follows:

The Case Management Cares Act Estimated Carryover reimbursement ceiling for the period of July 1, 2021 through June 30, 2022 is \$423,366.00.

The Community Services Cares Act Estimated Carryover reimbursement ceiling for the period of July 1, 2021 through June 30, 2022 is \$999,055.00.

Therefore, the Case Management Service Budget and Community Services Service Budget, are added and attached.
