*Project Title/Description:

Bookmobiles Antennae

*Purpose:

Funding will pay for three Cellular Paddle antenna and installation bundles, a set for each library van, to convert them into a mobile Wi-Fi Hotspot, providing much needed Internet access to distant residents who don't have broadband at home. Approval by Pima County Board of Supervisors authorizes PCPL to sign required application assurances, to submit its application for these allocated funds and request payment.

Not Applicable to grant awards.

*Program Goals/Predicted Outcomes:

The Pima County Public Library will deploy communications assets to provide students with valuable connectivity beyond the current health crisis.

*Public Benefit:

Pima County residents, specifically school students and their families will gain valuable connectivity beyond the current health crisis with free library provided Wi-Fi to access lesson plans and other educational resources.

*Metrics Available to Measure Performance:

Project evaluation will take place to collect information about patron response using surveys and interviews.

No. While this is an LSTA mini- sub-grant outside of the usual timeline, the period of performance on these 2020 funds begins June 24, 2021. If funding is not approved, Pima County residents in Internet deserts will not have broader access to Wi-Fi in their neighborhoods.

- b) If any funds other than Federal appropriated funds have been paid or will be paid to any person (other than a regularly employed officer or employee of the applicant, as provided in 31 U.S.C. § 1352) for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the authorized representative shall complete and submit Standard Form LLL, "Disclosure of Lobbying Activities," in accordance with its instructions.

6. Trafficking in Persons

The applicant must comply with Federal law pertaining to trafficking in persons.
