My firm has been involved in the concept for a significant multi-sport facility at Kino South since its inception and worked with County staff and leadership to develop a master plan. At that time, we thought it was an ambitious dream. Today, with the proposal from Knott Development and the support of the Board of Supervisors, that dream is about to be a reality.

On the personal side, as the mom of a club volleyball player, I've spent countless weekends making trips to Phoenix, Las Vegas, and other national venues. I can count on one hand the number of tournaments she played in Tucson, simply due to the lack of facilities. Sporting Chance is the only venue that's built for tournaments, and its six courts are simply not enough for a metro region of one million. It's not only discouraging for the athletes and families to travel all the time, but it's a massive loss of revenue for our community.
