Dear Board of Supervisors,

My name is Frank Baden and I am a loyal, yet concerned, employee of the city of Tucson, having worked as a civilian member of TPD for the past twelve years. I am also writing as a resident of Pima County, on behalf of my family, to urge the board to oppose any policy that would mandate Covid-19 vaccinations for Pima County employees. Such a mandate would be counterproductive to the county's efforts to prevent a loss of jobs and services, and would be an unnecessary punitive step in combatting the much less severe delta variant responsible for few hospitalizations and deaths, to date. Those wishing to avoid the vaccine may have good personal reasons for doing so, but it must remain their choice, as it is in other medical circumstances. Denying and/or leveraging medical choice is a slippery slope toward tyranny, and ND 8 politicians should not be mandating medical choices, especially when the science is rapidly changing, and new MORDERCOKUT information is constantly emerging regarding the efficacy and longevity of the vaccine and its role in causing the emergence of new viral iterations.

From a legal standpoint, Article 4.2, Section 36-681 of SB1824, which was recently incorporated into the passed and signed budget by Governor Ducey on 6/30/21, deals with Covid-19 passports/prohibitions. It reads:

NOTWITHSTANDING ANY OTHER LAW, THIS STATE AND ANY CITY, TOWN OR COUNTY OF THIS STATE ARE PROHIBITED FROM ESTABLISHING A COVID-19 VACCINE PASSPORT OR REQUIRING EITHER OF 9 THE FOLLOWING: 1. ANY PERSON TO BE VACCINATED FOR COVID-19.2. A BUSINESS TO OBTAIN 29 PROOF OF THE COVID-19 VACCINATION STATUS OF 2 ANY PATRON ENTERING THE BUSINESS ESTABLISHMENT, 3 B. ANY LAW OR ORDINANCE ESTABLISHING A COVID-19 VACCINE PASSPORT IS VOID AND IS NOT ENFORCEABLE AGAINST ANY PERSON OR BUSINESS LOCATED IN THIS STATE.

A vaccine passport is when proof of vaccine is required in exchange for something else, like a job. No political subdivision within the state may impose a vaccine passport and doing so will likely expose the county to untold justified lawsuits when affected individuals are tied to that subdivision directly through employment or contract. Protections sealed under Executive Order 2021-09 are set to expire on September 29, 2021 when the aforementioned permanent legislation takes effect.

On 7/30/21, The CDC published on its website a study concluding that during the month of July 2021 in Barnstable County, MA, 74% of the 469 identified new cases of Covid-19 occurred in fully vaccinated people https://www.cdc.gov/mmwr/volumes/70/wr/mm7031e2.htm?s_cid=mm7031e2_w

These results are contrary to the established narrative that we're facing a "pandemic of the unvaccinated," and further indicate, along with 518,769 reports of vaccine injury and 11,490 vaccine related deaths on the VAERS website (as reported by the Liberty Counsel, as of July 23), that these emergency authorized drugs must not be mandated, even after eventual approval by FDA. It cannot be acceptable that the populace is being used as

collateral damage to facilitate any agenda, be it in the name of "health" or otherwise. It is one thing to be a casualty of one's own decisions, but quite another to be a casualty of a government claiming to protect you from "it." We must assume the risk, not government. This is exactly why the Nuremburg Code was established after World War 2. Historically, every vaccine program has been shut down when it approached only a fraction of these reported casualties. Furthermore, these drugs do not even work like traditional vaccines, and can be more accurately described as experimental gene therapy in their mechanisms of action. Because of the unpredictable nature of the spike protein and how they've manifested, it is unwise and unhelpful to make generalized claims about long term health repercussions at this early stage.

I enjoy my career with the City of Tucson and love the productive feeling I get from serving the public daily. I could never have imagined that govt overreach in response to a virus that was created with our own taxdollars in a foreign lab would ever have threatened to cut short so many of our careers. My family, comprised of highly educated doctors and public servants, has spent many months researching a multitude of aspects regarding Covid-19 vaccines, and have concluded that based on these and additional factors, they should not be justified from a legal standpoint, or as a moral imperative. Please consider my thoughts as you take this aspect of our lives and livelihoods into your hands. Whatever Pima County does on this front is surely to impact any future decisions of the likeminded City Council of Tucson. It should be sufficient, especially in America, to provide options to citizens and encourage them to make informed choices, but unfortunately, this is not what we're seeing, largely, in the midst of this unprecedented event.
