Hello Board of Supervisors,

Vaccination should never be a mandate. It is a personal decision. No one's job should be threatened to a management position dictating health decisions.

Whichever vaccine is administered, it is NOT a cure, nor will it prevent COVID nor the spread of COVID. Facts support this:

Those post-vaccinated COVID positive individuals can transmit the disease as readily as unvaccinated individuals.

Thousands of individuals have contracted COVID after being vaccinated.

Fully vaccinated people who get infected carry as much viruses in their nose as unvaccinated People.

To Pima County Supervisors,

Mandating any vaccine for all health care workers regardless of any knowledge of individual health situations or allergies or religious or philosophical objections is a clear violation of human rights.

The Nuremberg code states: The voluntary consent of the human subject is absolutely essential. I have more than 25 years of experience writing about protecting and promoting health in both mainstream books and magazines. Please take note of regular order and the Supreme Law in the Federal Constitution and of Arizona State in the Constitution.

Please also take note of the definitions regarding the extreme maladministration and over-reach of power you have been exercising and are about to over-step once again.

The People are watching. Remember you oath which binds you.

Arizona Constitution Article 2 Section 2. Political power; purpose of government

Section 2. **All political power is inherent in the people, and governments derive their just powers from the consent of the governed, and are established to protect and maintain individual rights.** [Emphasis added]

Arizona Constitution Article 2 Section 4 Due process of law

Section 4. **No person shall be deprived of life, liberty, or property without due process of law.**

Mandate: a command, order or direction, written or oral, which court is authorized to give and a person is bound to obey. **A judicial command** or precept proceeding from a court or judicial officer, directing the proper officer to enforce a **judgment, sentence** or decree.

When were any of the people convicted or found guilty in a court of record with a jury of our peers, facing our accusers who have sworn affidavits to find the facts regarding harm?

When did you get authority to decide a case not even in the courts and issue the ruling?

Where did you get the authority to trespass on the people's rights by taking on a judicial function - decreeing a punishment reducing the liberty of the people by such things as wearing a mask or forcing an injection or restricting movement?

If you believe you have such authority to trample on the the people's rights that you swore by oath to protect and maintain, please show where in the Constitution you got that authority.
