"My doctor only took one of my calls saying she was hearing this with too many patients, and I have to just wait it out," Ella says. "I could not move my entire arm down to my fingers, nor my neck in any direction. This was the second time I thought I was going to die."

Death came near, first, because of COVID; second, the Moderna shot. And the feelings in her

# body got even weirder.

"The sensation in my head and arms was like soda pop bubbles popping and never stopping," she writes. "This lasted for three days."
